# A/E Presentation

## **DRB Comments**

## A. General

• The Design Review Board understands the need to escalate review of certain elements of the site design in order to allow time for the city's flood plain review process. The design team provided a good explanation of the necessary changes to the site design. The DRB appreciated the budget update.

## **B. Site Architecture**

- Continue to study the entrance to the site from the corner of Athens and 19<sup>th</sup>.
  - How is the site accessed?
  - How are the buildings accessed? Is there a more direct way to access the buildings from the northeast?
  - What is the best approach to the site?
- Consider alternatives to various site elements along 19<sup>th</sup> on the east side of the project site.
  - $\circ$   $\;$  Should the stairs on the north side mirror the stairs on the south side?
  - Should some terracing be added from the street level up to the walkway alongside the building?
  - Could the walkway alongside the building bump out in one place to add interest, engage with the Terrace Green, and provide more seating?
- Should the south terrace steps move to the west in order to provide more direct access to the main courtyard?
  - The revised courtyard design is good.
- Consider adding shading to the terraces.
- Explore whether the seat walls and retaining walls can be softened can they mirror the curves and angles of the buildings?

- Can the number of pathways along the south and west side of the site be reduced?
  - Can one set of stairs be eliminated if the pathway is reduced?
  - Reducing the pathways provides more opportunities to engage with the landscape.
- Look for ways to edit the terrace walls, which could include reducing, breaking, sloping, etc.

#### **DRB** Action

No formal action was required. The DRB provided the comments and direction noted above based on the workshop discussion.

There being no further business, the public meeting of the Design Review Board adjourned at 2:00 p.m.
