Description: This project is proposed for POD J by a private development

manager (NexCore Group) in conjunction with CUREF as the owner for a known tenant (University of Colorado Hospital Authority). The proposed building is approximately 52,220 GSF on two levels (including shelled expansion space) with a portion of the parking below the building. Site work includes surface parking, a patient entry drop-off area, one side of the street-level CU Campus entry signage, and integration of on-site wetlands

area into the overall site landscaping.
