#### • Roll Call and Introduction

### • Mid-AY Review of Previous Meetings

#### **Faculty Senate Grievance Committee Update (October)**

The committee reviewed the composition and charge of the Grievances committee, then discussed what representation and advocacy is available to faculty.

- The committee has reviewed 2 grievance cases (1 denial of tenure and 1 academic rights). We might be seeing an increase in alleged violations of academic rights cases.
- No patterns that have been identified at this point.
- Faculty can review grievances and all other campus remedies must be exhausted before
  this committee can review the case. Any allegations of campus discrimination are
  handled by the Office of Equity and this committee has no discretion over those offices.
  This committee doesn't automatically advocate for faculty.
- Discussion: If this committee doesn't advocate for the faculty, who is supporting the
  faculty? The Faculty Senate is the main body that advocates for the faculty. This
  committee educates people through the process. The Faculty Senate should know that
  there are resources on campus for faculty and what those are on each of the respective
  campus.

- The committee also discussed progress and implementation of the Equal Pay for Equal Work Act.
- The committee had asked about the Equal Pay for Equal Work Act and status of this assessment.
- This work has been done and the system made adjustments, the committee has requested a report from the chair of FC; the committee will reach out to system admin once again once there is more clarity regarding the budget.

#### • SDO Judi Diaz Bonacquisti met with the Senate and provided an update in October.

Judi Diaz Bonacquisti introduced herself, her role, and the role of the office. Then she briefly reviewed recent activities:

- She has met with the DEI VCs on each of the campuses; working on revision of the CU non-discrimination policy; updates about the Regents.
- Process for the selection and award process for the President's grant; deadline of February 6th.
  - Hiring: An opening for the position of the director of DEI in the office of Strategic Initiatives.
- President selection process open to review.

Judi Diaz Bonacquisti opened the floor to questions.

- A question was raised about accountability and actual processes that ensure equity.
  - The committee discussed transparency issues and from where they are originating.

  - Concern around the handling of finances and the System emails that funds are being pulled.
  - Impacting monthly student-facing positions.
- Discussion of impact on the campuses and concerns around what this means for current and future strategic plans.
