\$36.8 million HEERF I – Fully Allocated

Student Share = \$18.4 million

- Emergency financial aid award process at each campus
- FAFSA either required or conditions considered
- Used on COVID-19 related expense that is part of Cost-of-Attendance
- Award amount based on student circumstances
- All HEERF I Student Share awarded (most in FY 2019-20 remainder in FY 2020-21)

<u>Institution Share = \$18.4 million</u>

- Used to "cover any costs associated with significant changes to the delivery of instruction due to the coronavirus..."
- Student housing, parking, and transportation refunds
- Personal protective equipment
- Curriculum changes and technological improvements related to COVID-19



\$62.0 million HEERF II Fully budgeted, being allocated reviewing guidance

Student Share = \$18.4 million

- Emergency financial aid award process at each campus (same as HEERF I)
- Cost of attendance: Tuition, food, housing, health care, mental health care, and childcare
- Award amount based on student circumstances
- Prioritize students with exceptional need
- HEERF II Student Share awarded in Spring 2021
