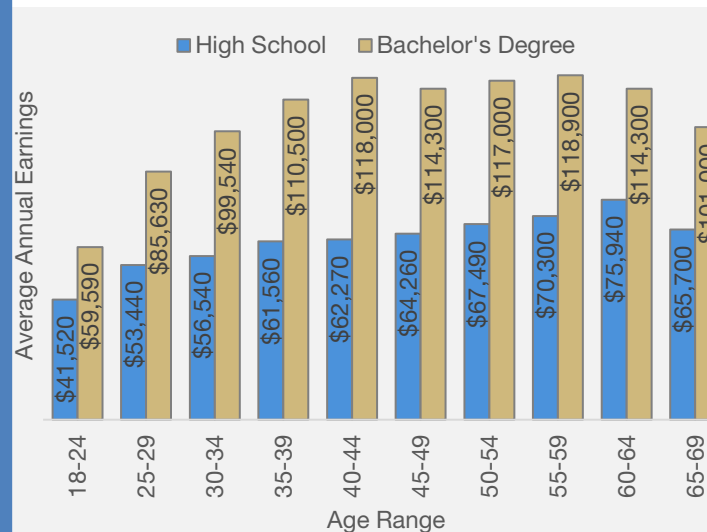

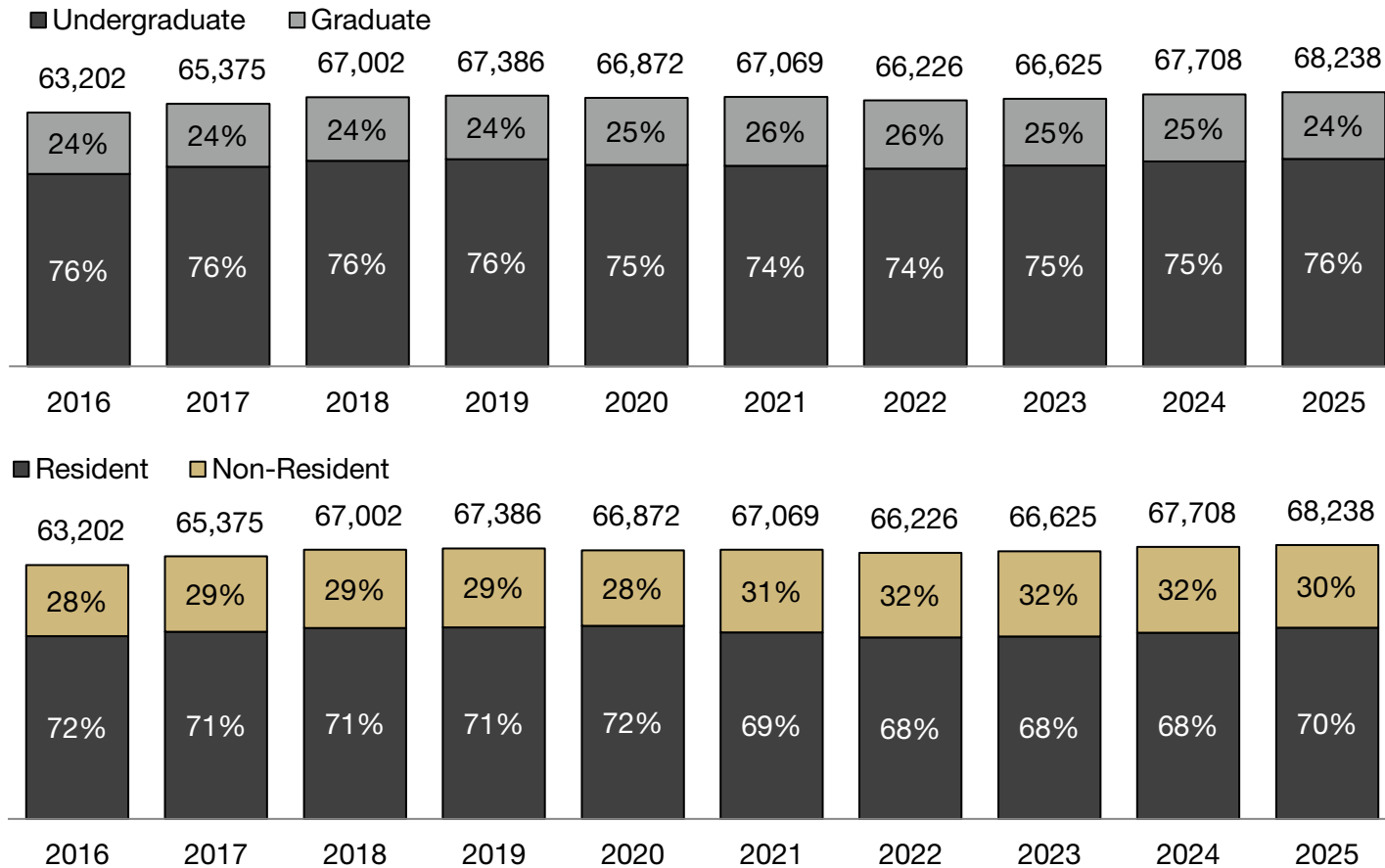

% Change From Prior Year

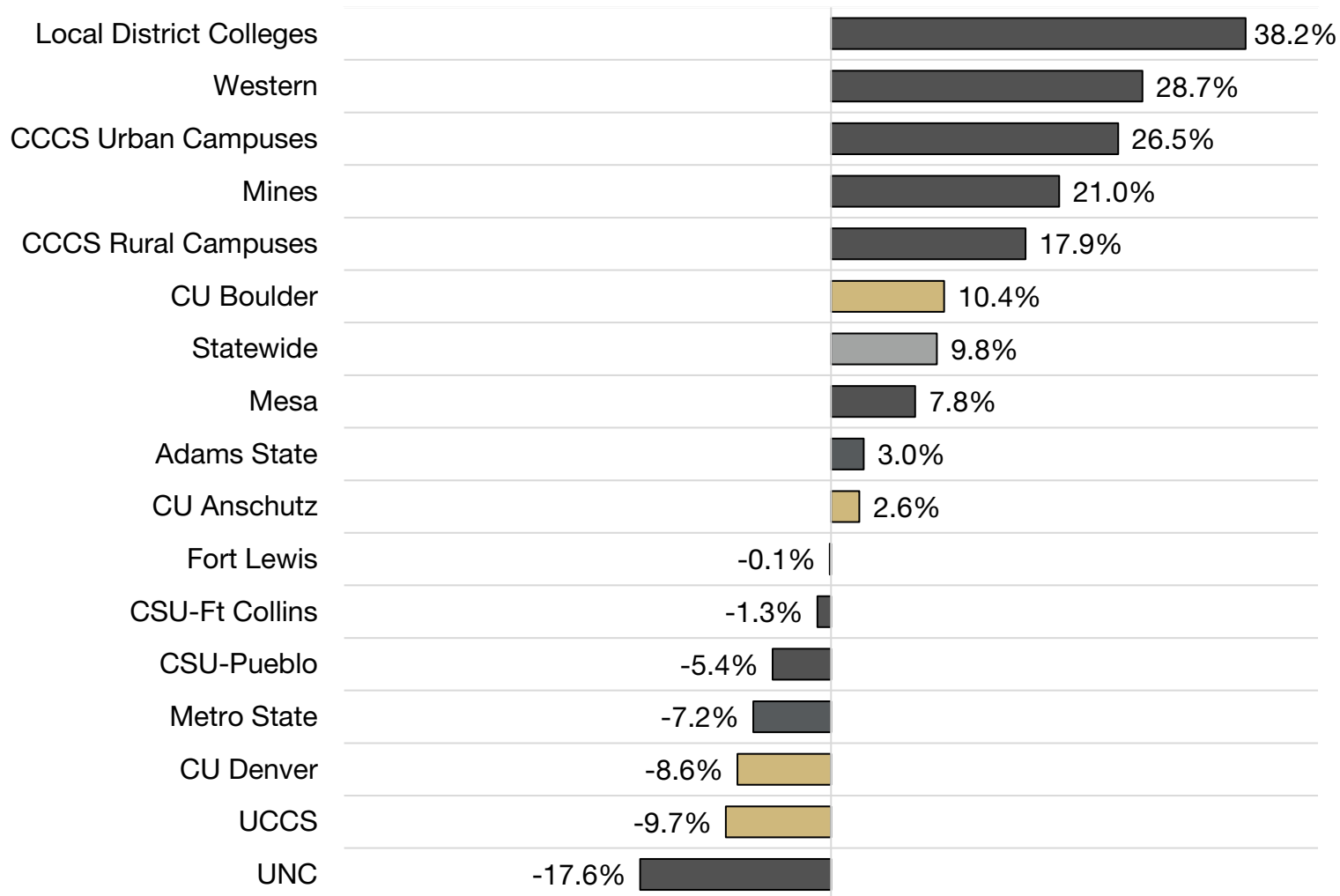

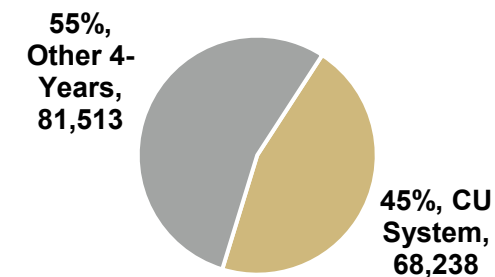

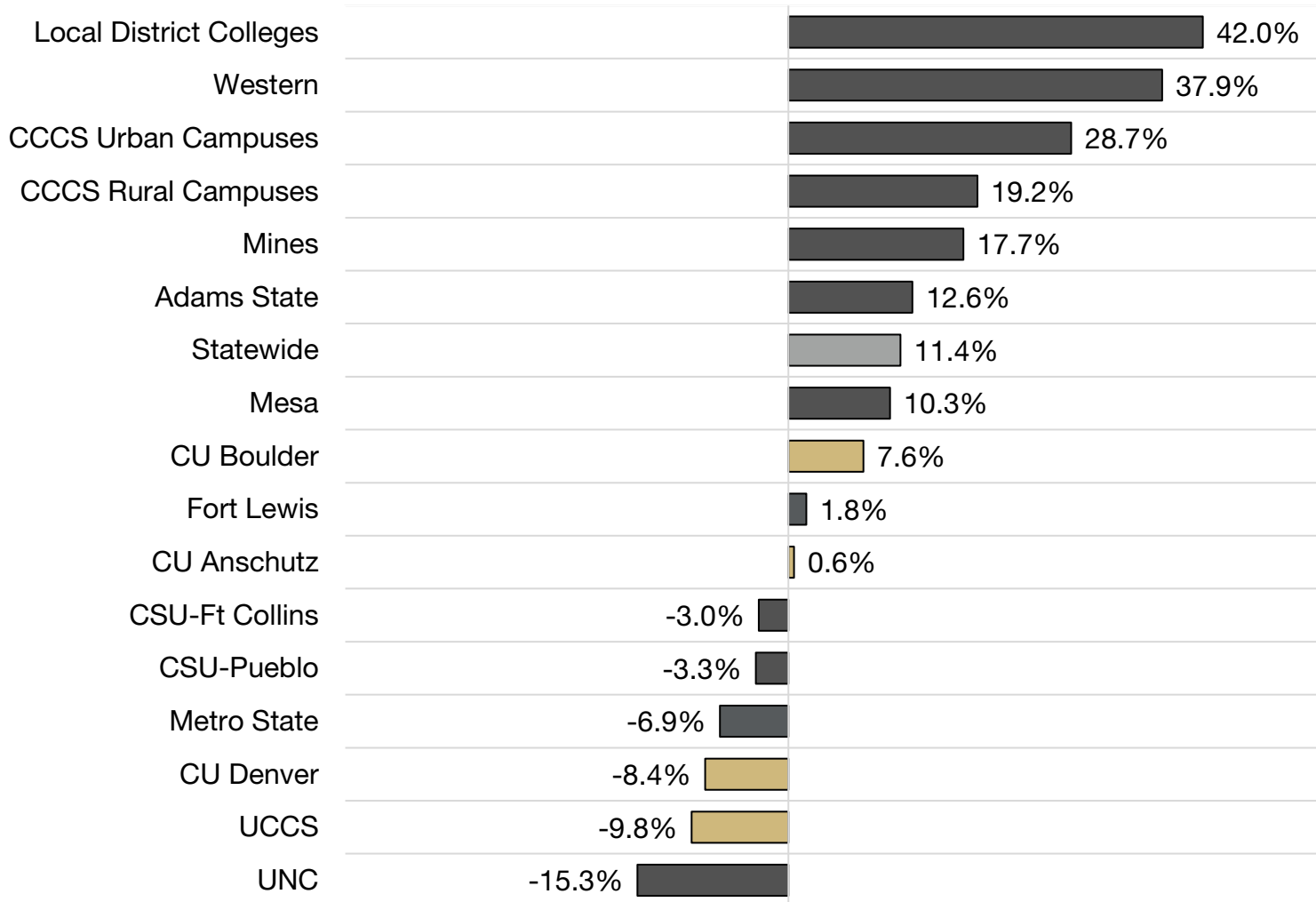
% of 4-Year Institutions

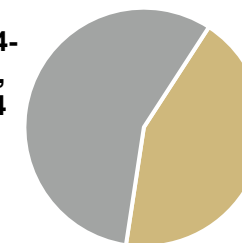

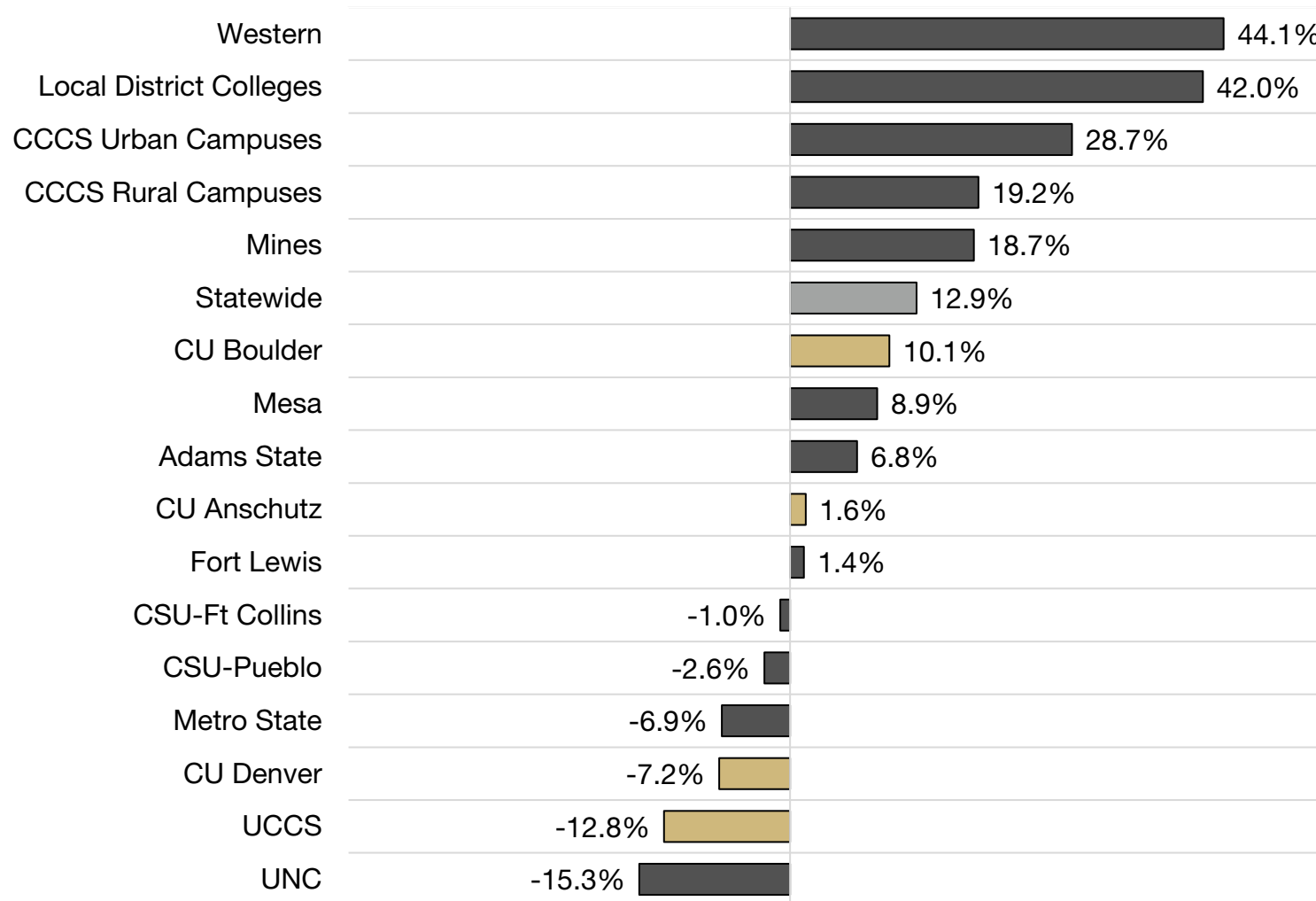

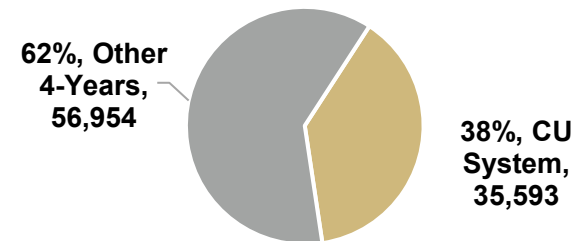

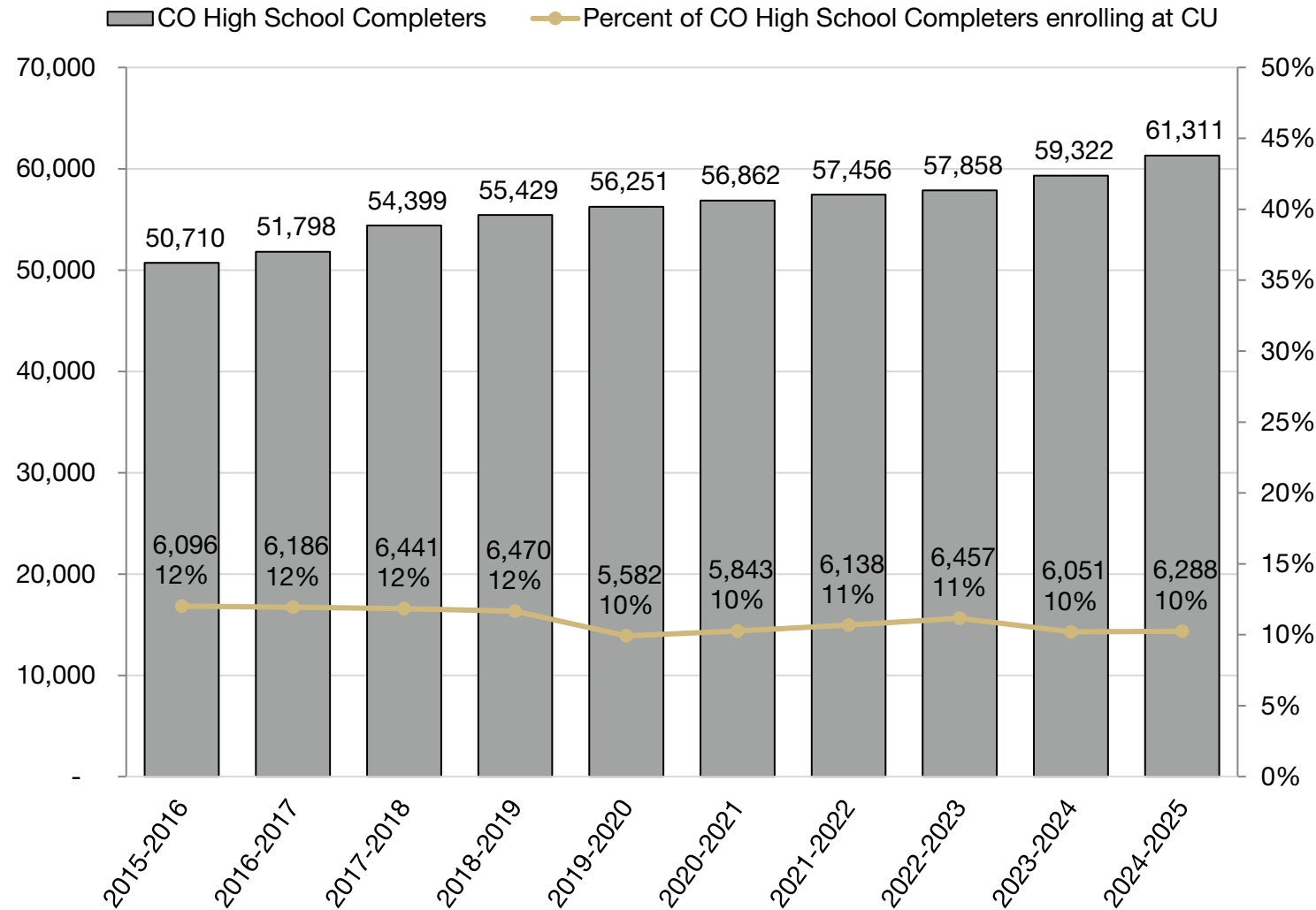

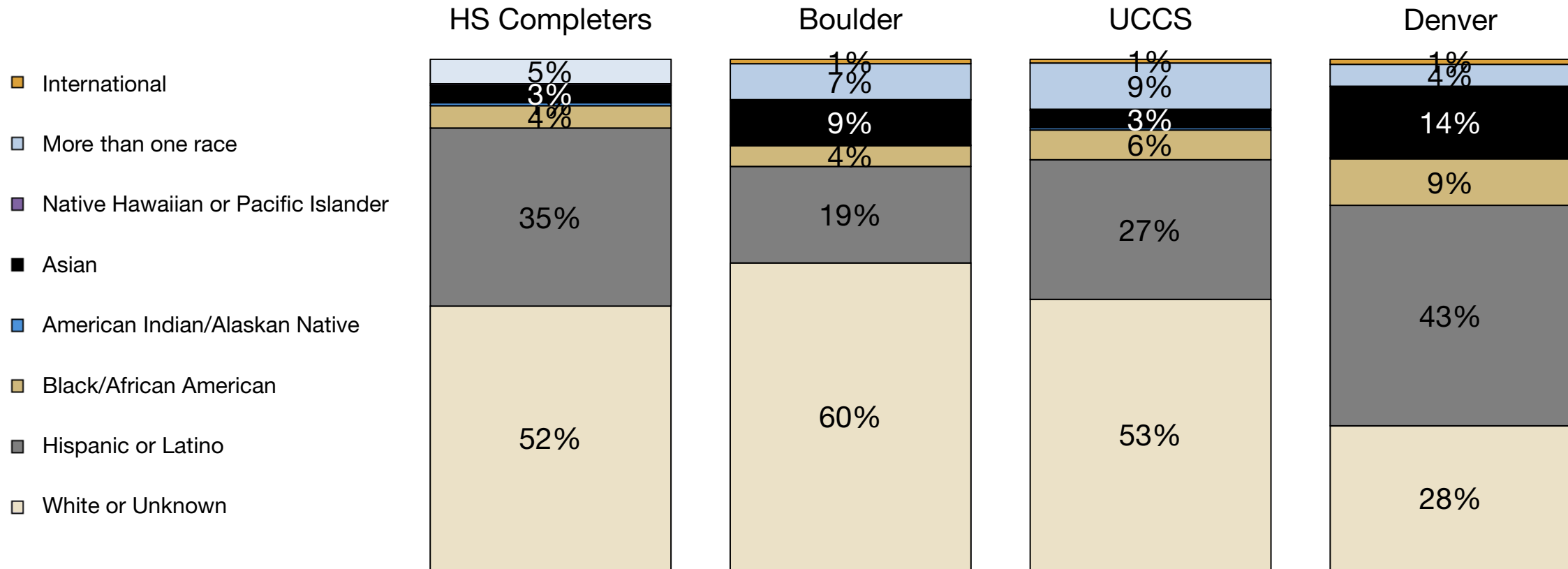

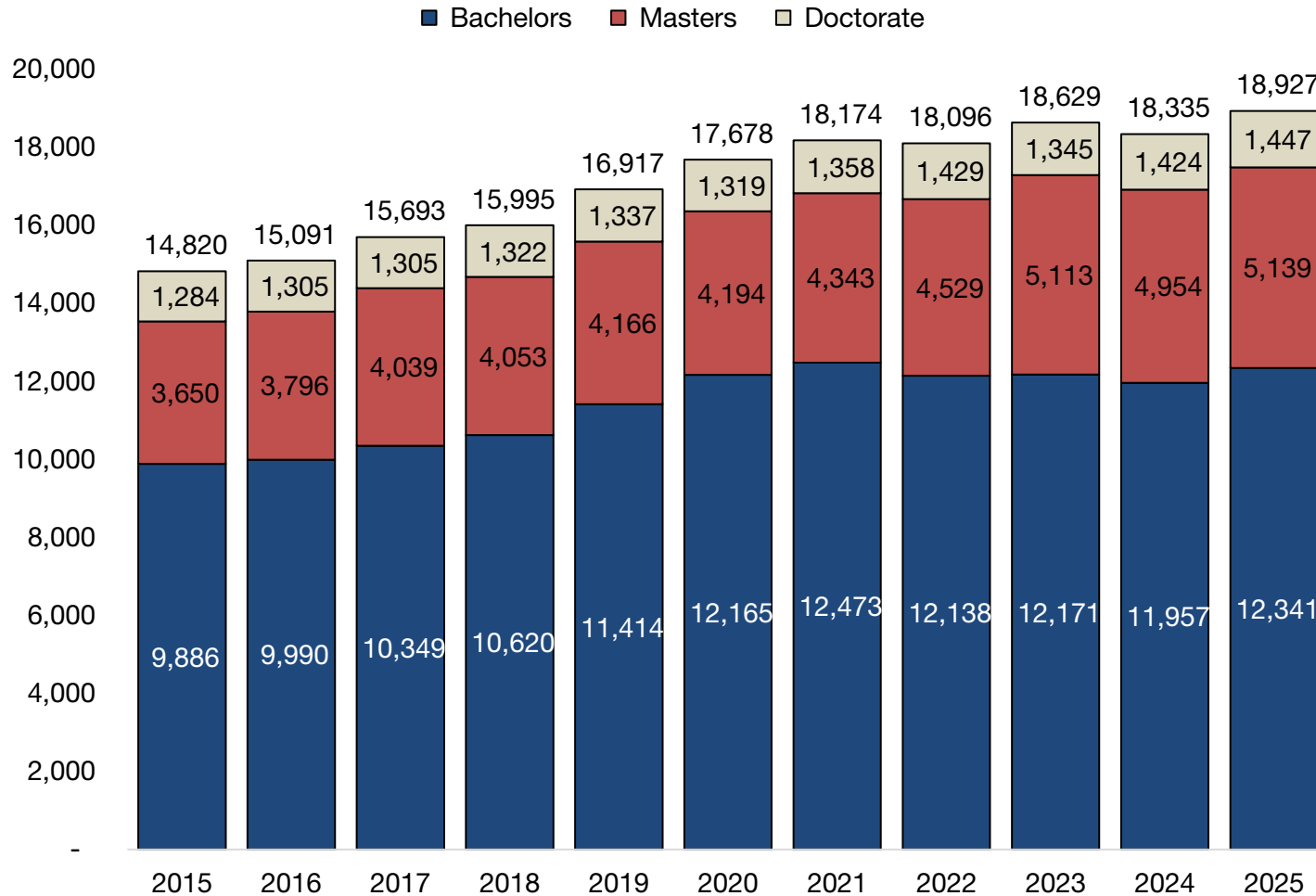

2024-25 Colorado High School Graduates, Fall 2025 CU Enrollment of Resident First-Year Undergraduates



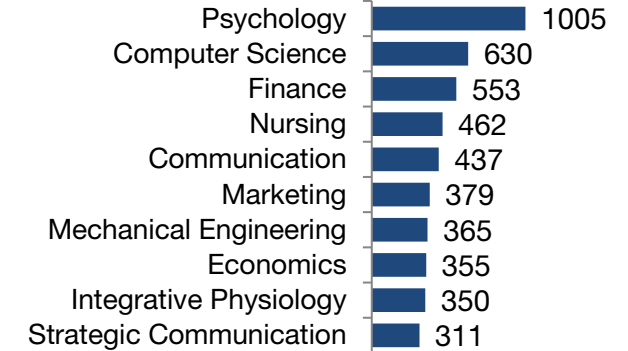

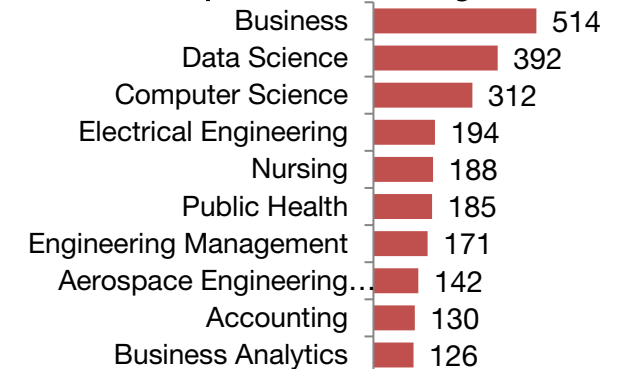


Top Fields of Study Awarded (FY 2025)

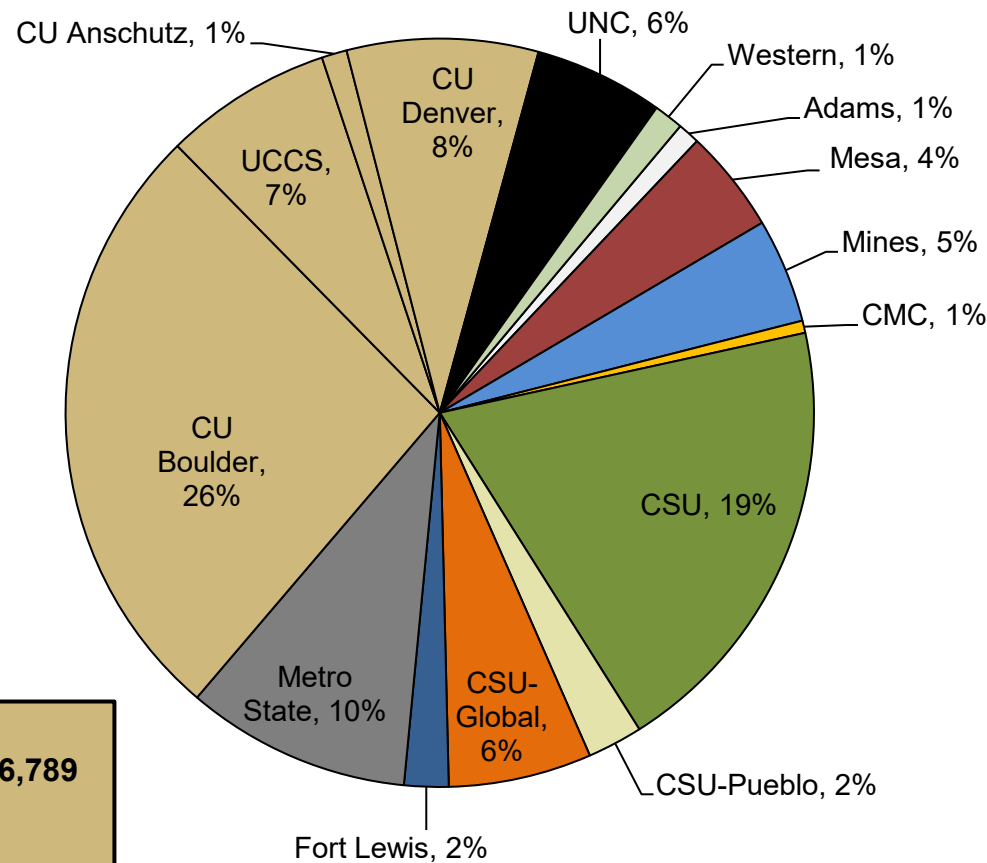

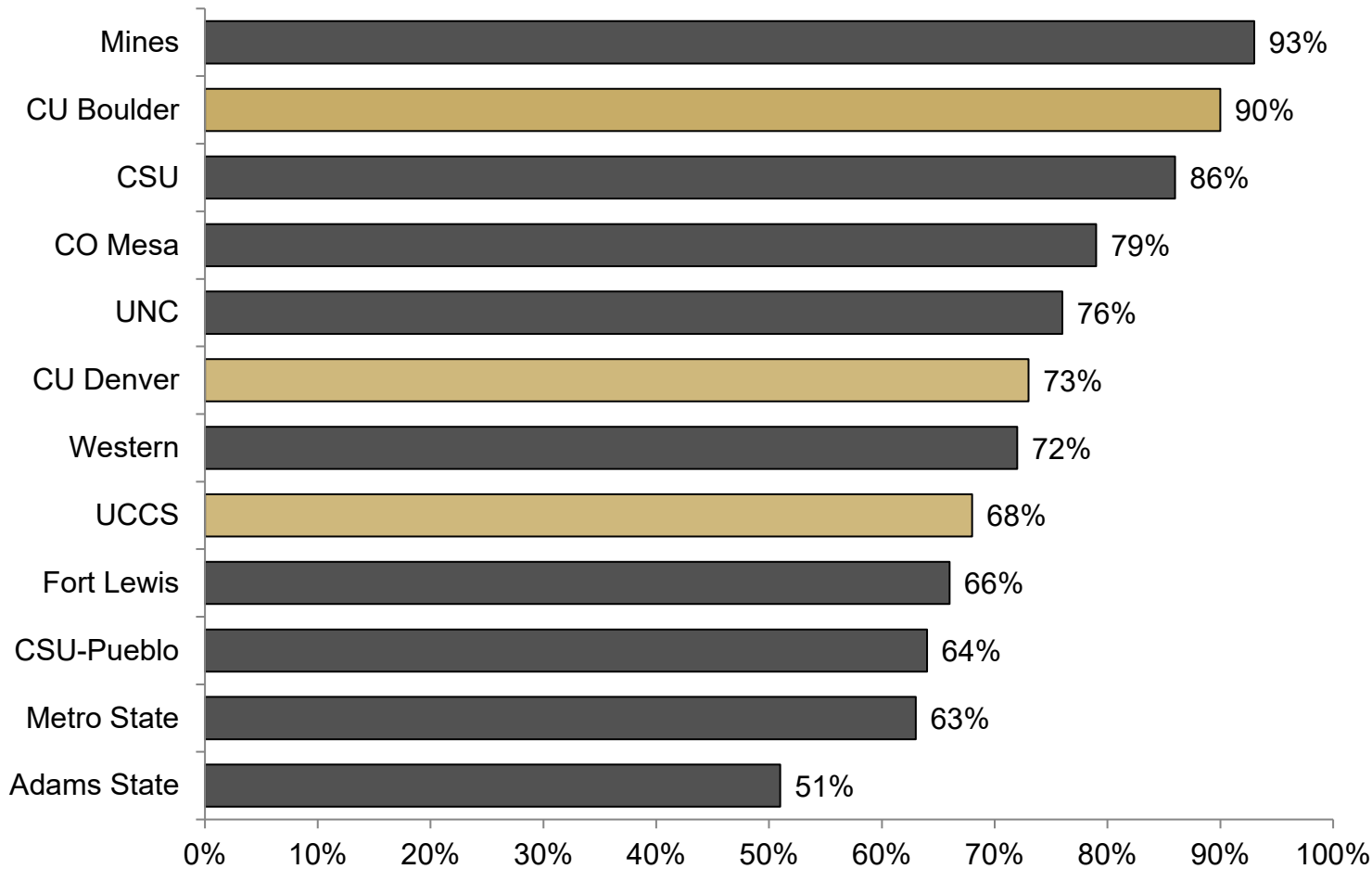

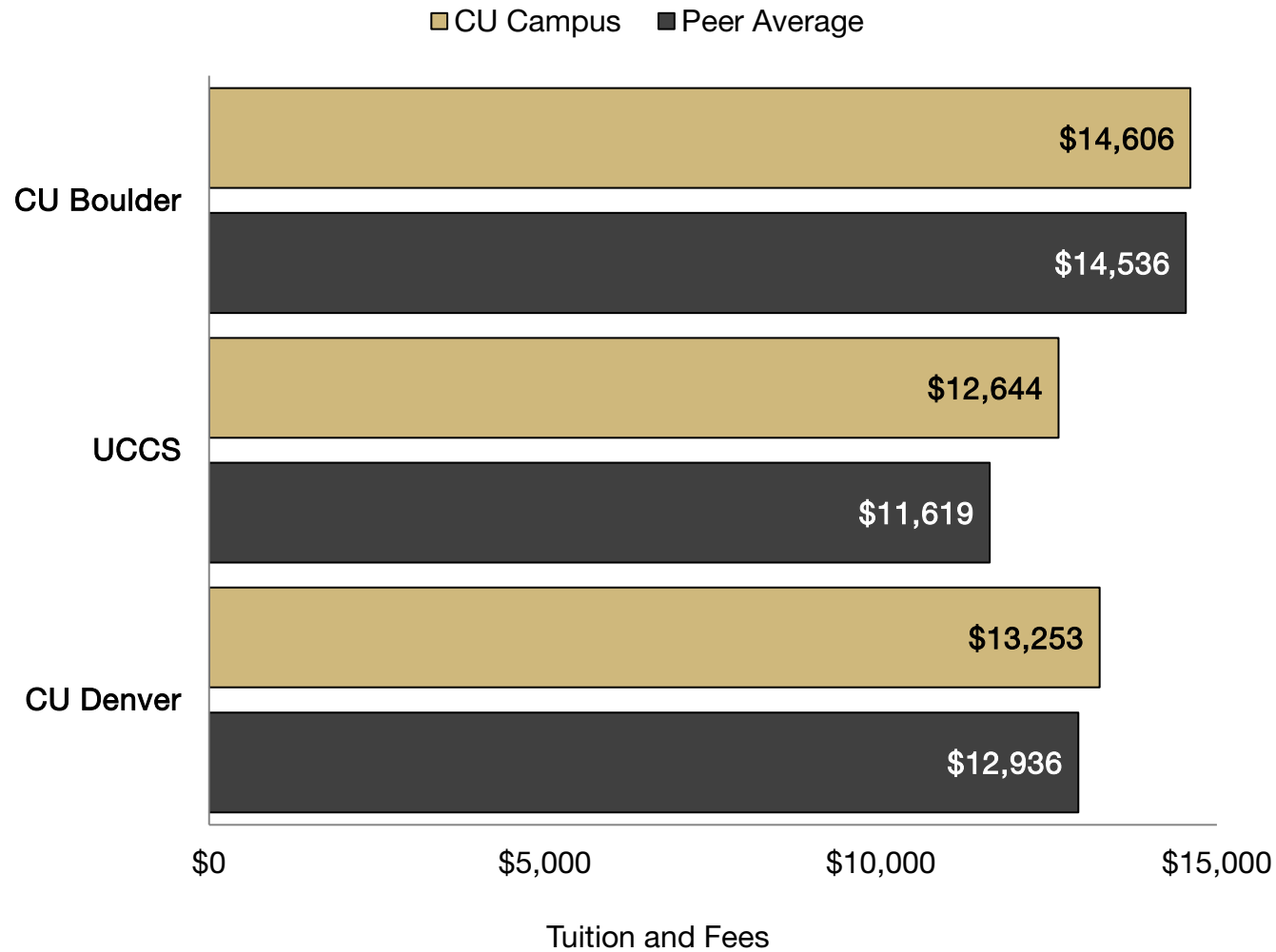


6-Year Graduation Rates (First-Time Freshman)

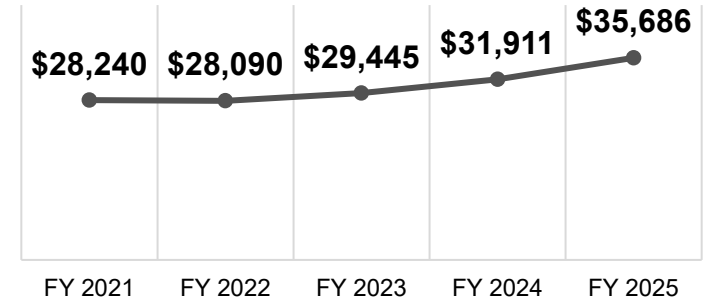
FY 2025-26 Resident Tuition & Fees Compared to Peers

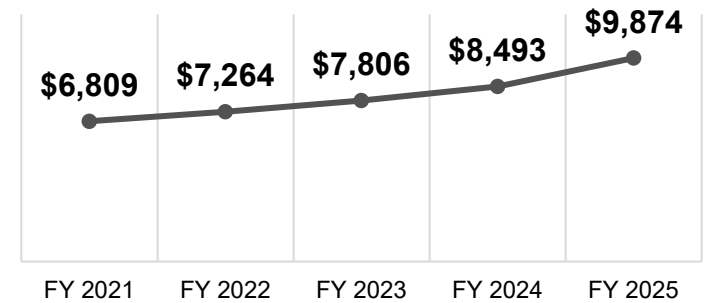

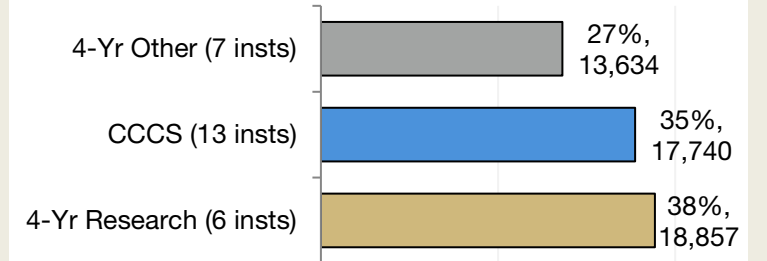
Student Financial Aid: Federal Pell Grants

Federal Pell Grants, the largest source of federally funded grants, are awarded solely based on financial need (academic grades and extra-curricular activities aren't a factor). Recipients must meet general federal student aid eligibility requirements. The maximum Federal Pell Grant award for the 2024-25 academic year is \$7,395.

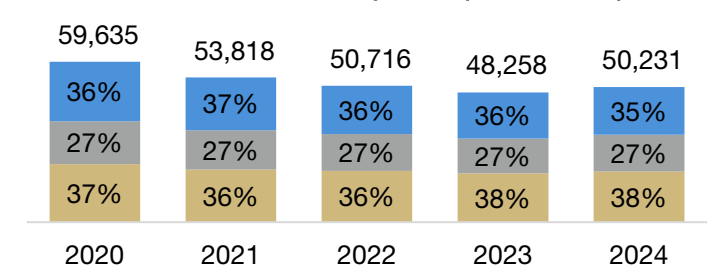
Pell Recipients at 4-year public institutions (IPEDS 2024)



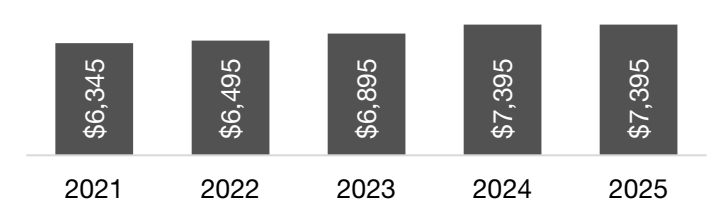

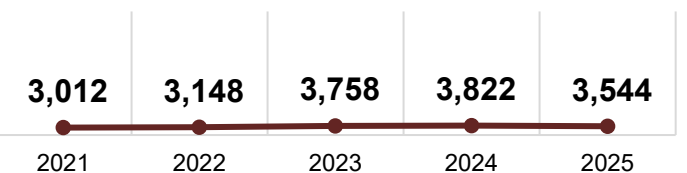

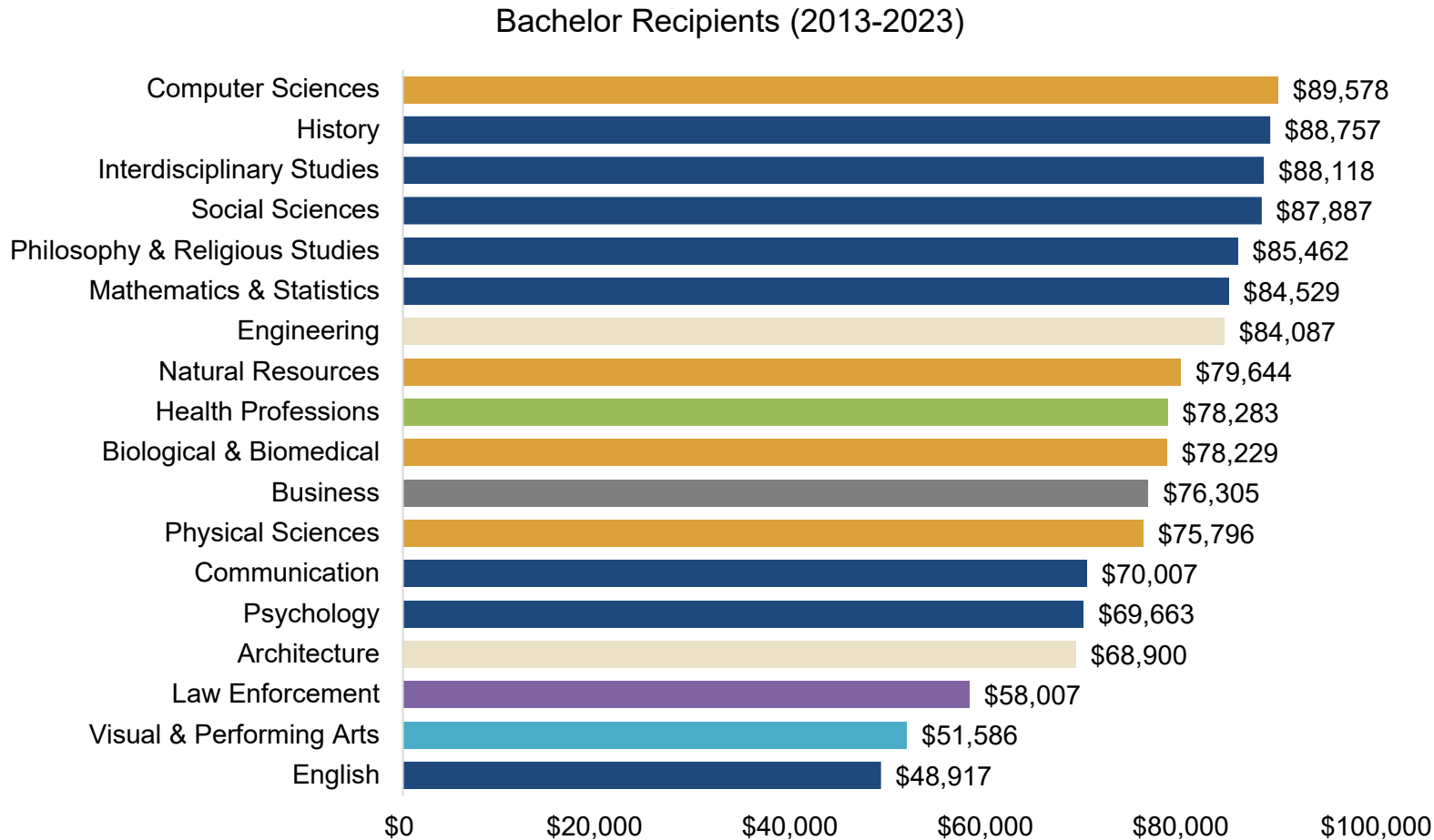
Number of Students Enrolling in Online Courses

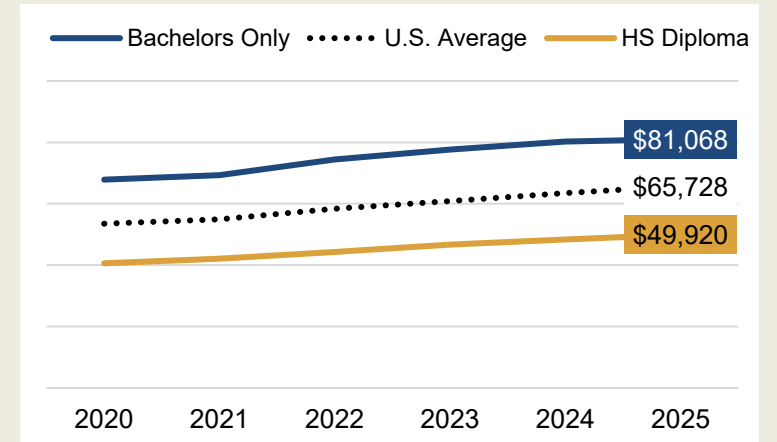

U.S. Median Annual Earnings (2025)

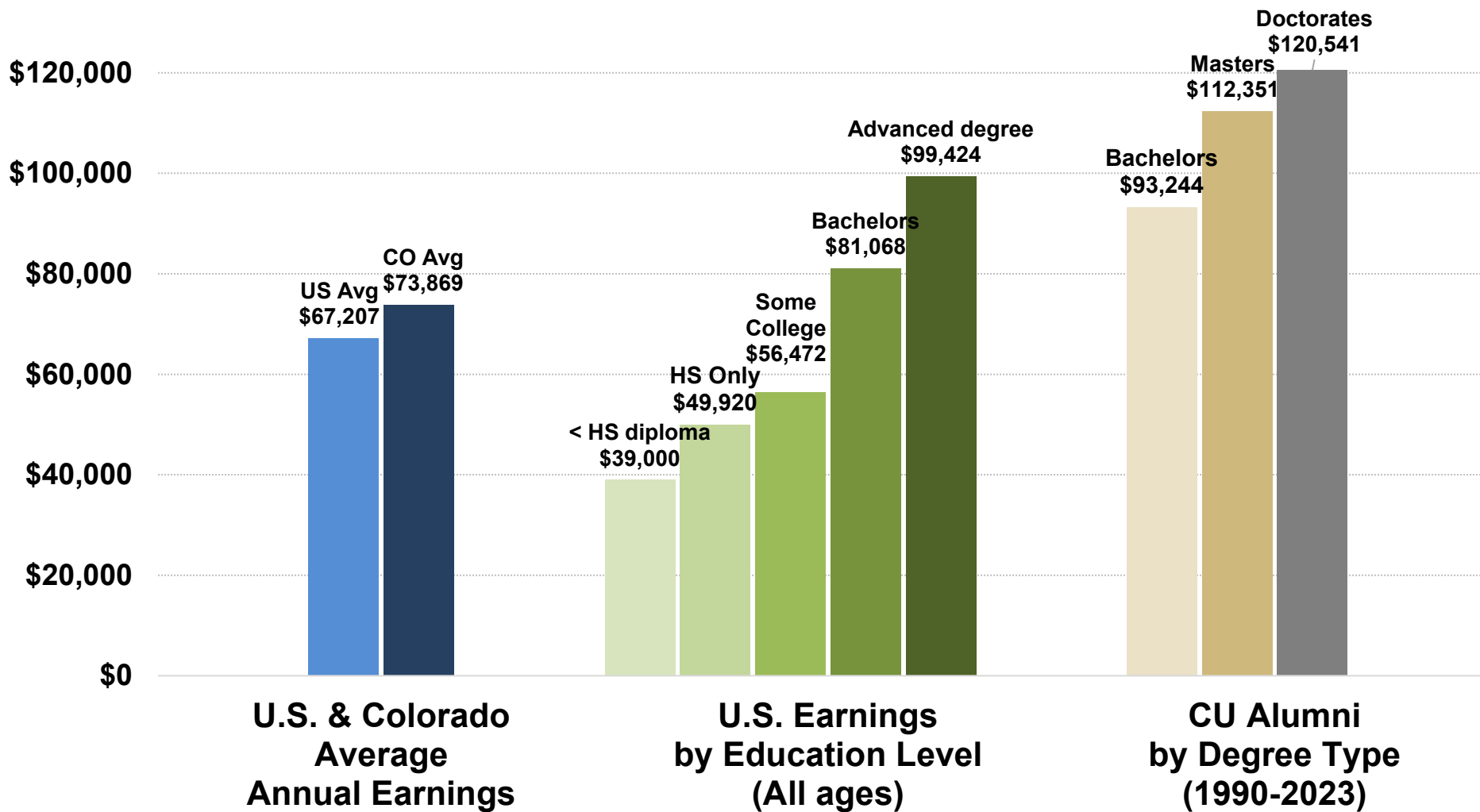

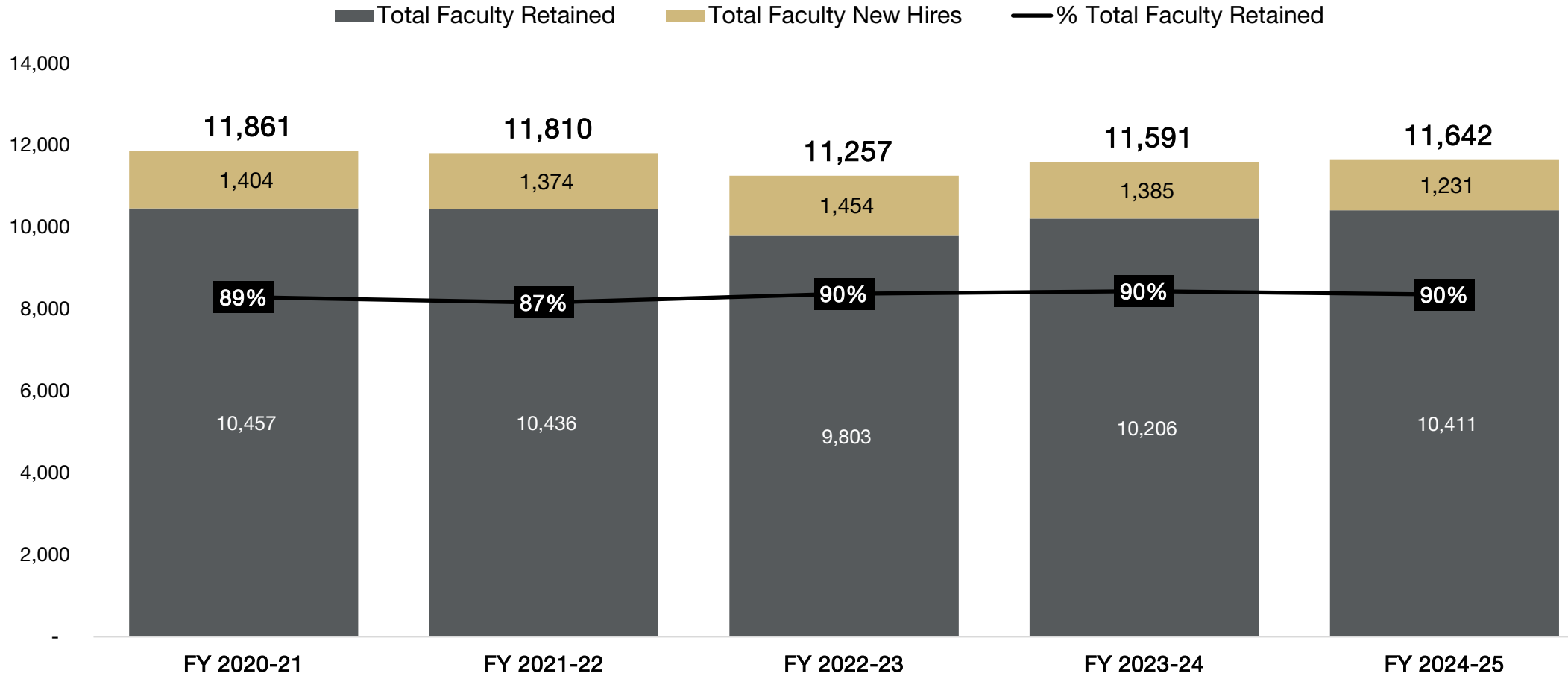

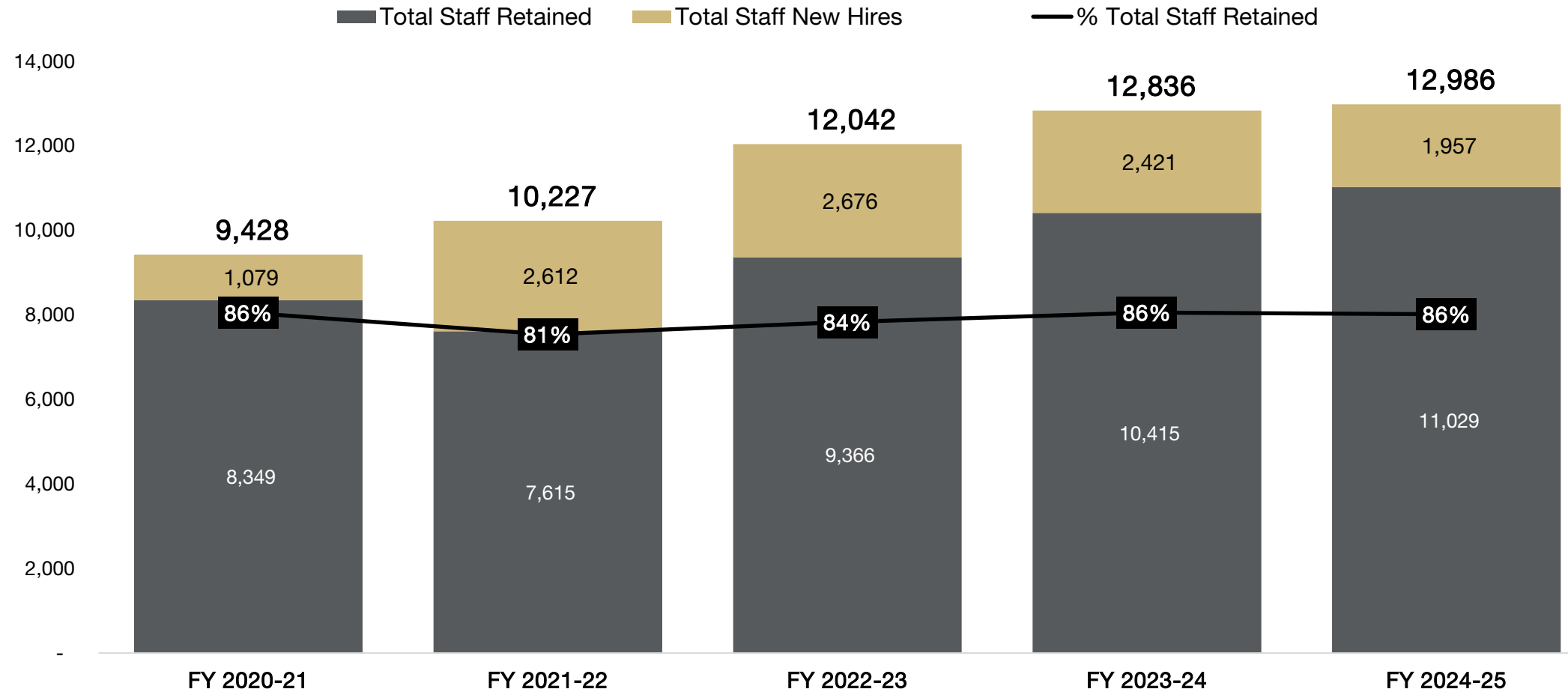
Faculty Population | Retention + New Hires

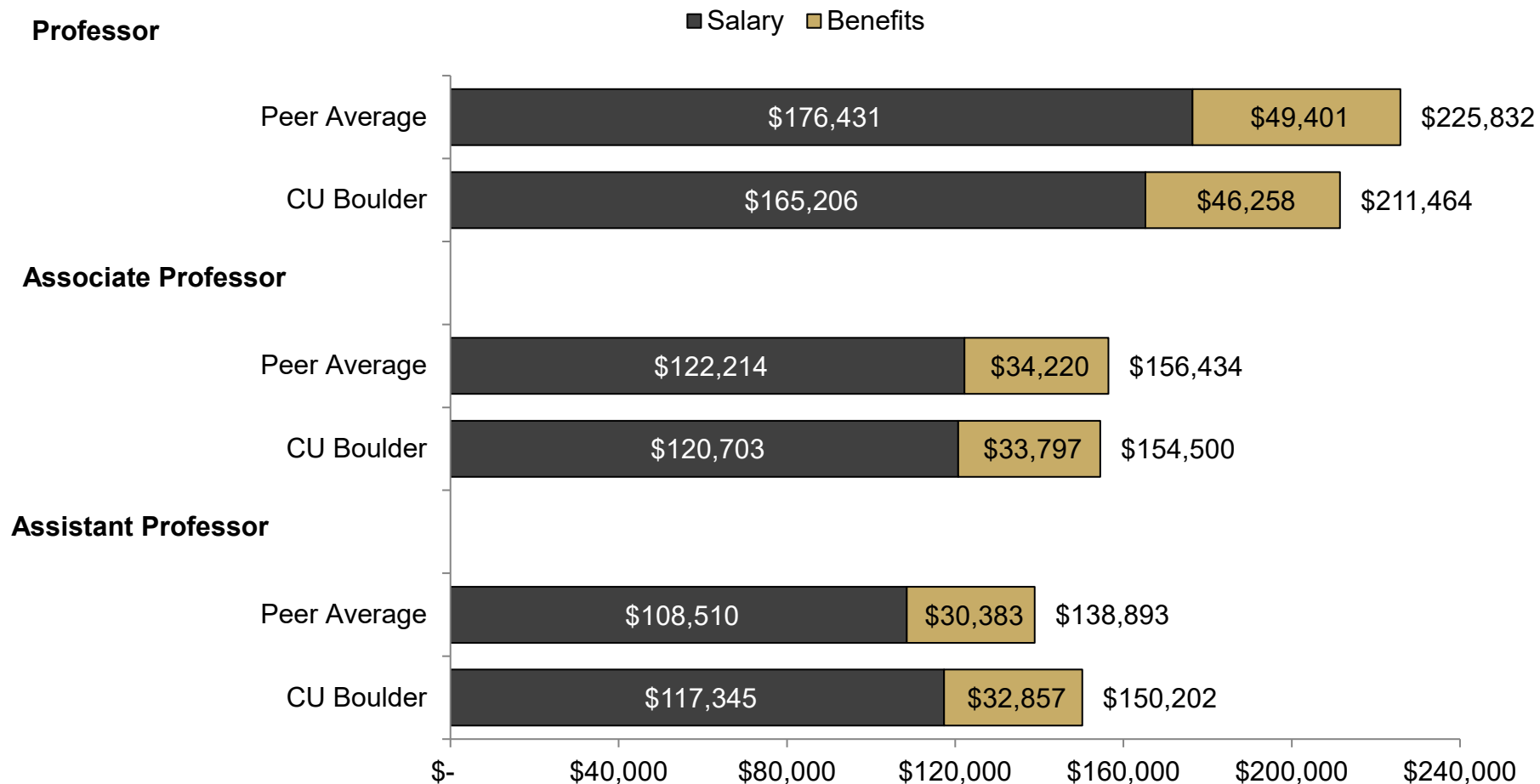

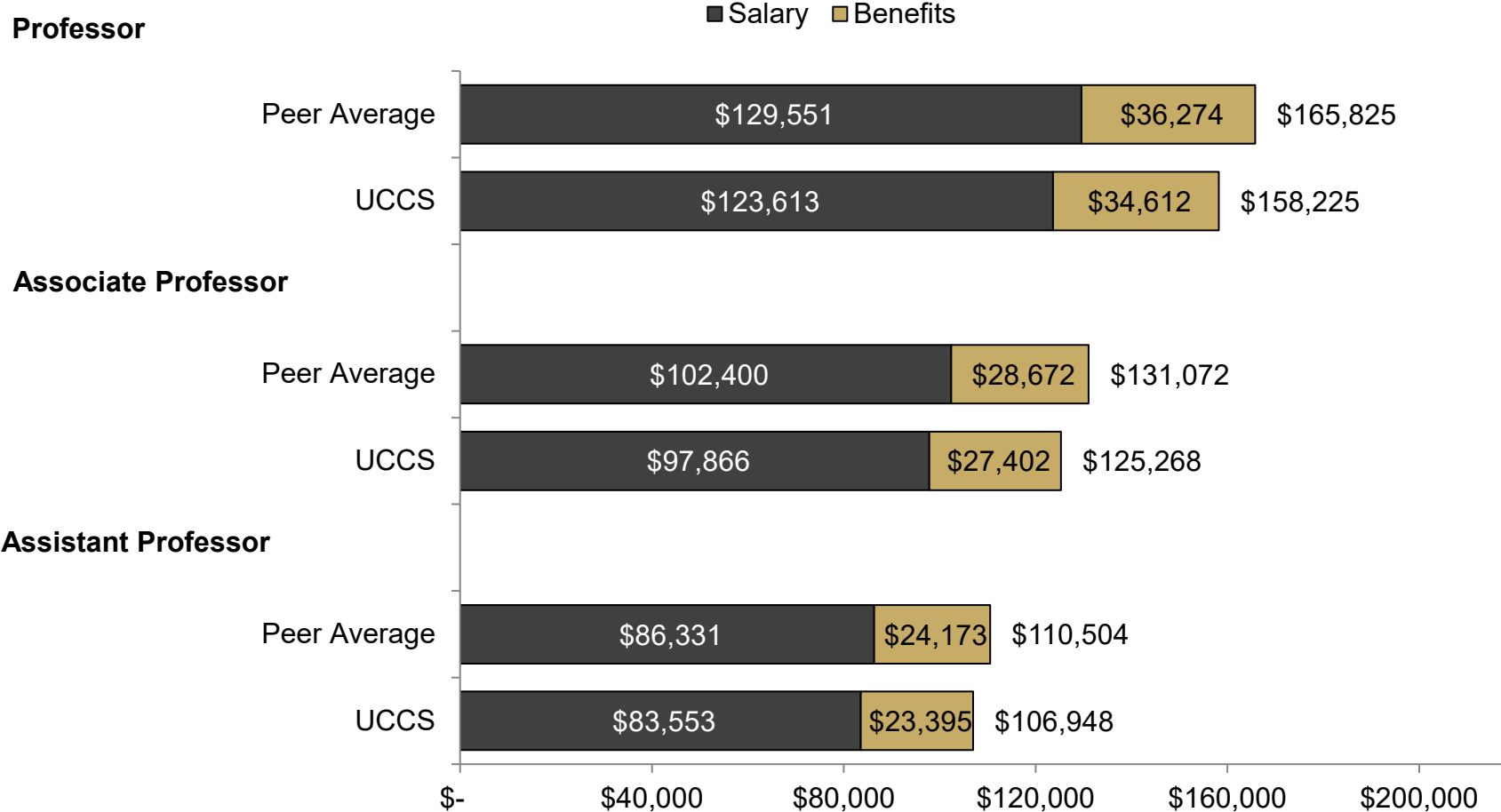

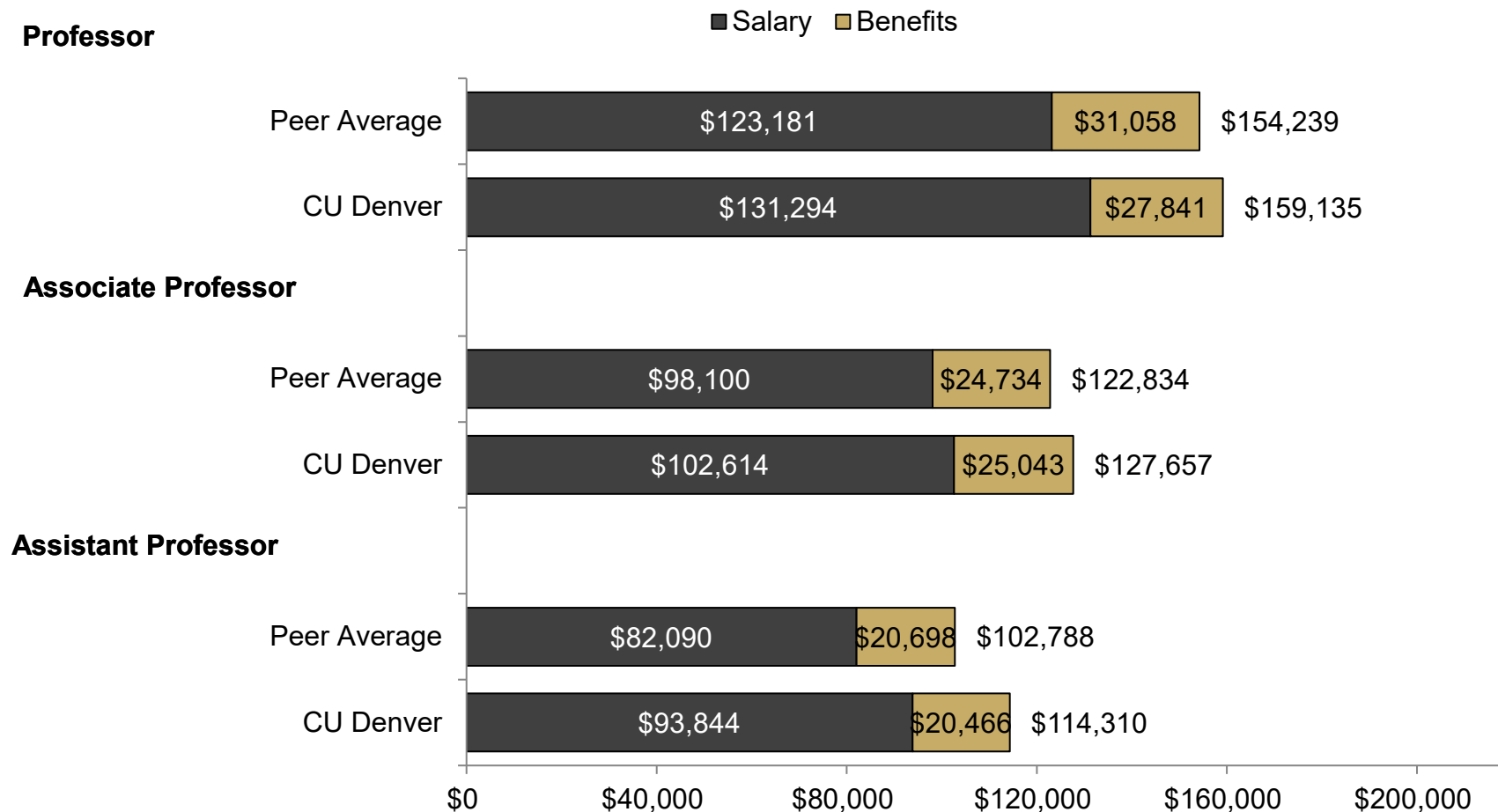

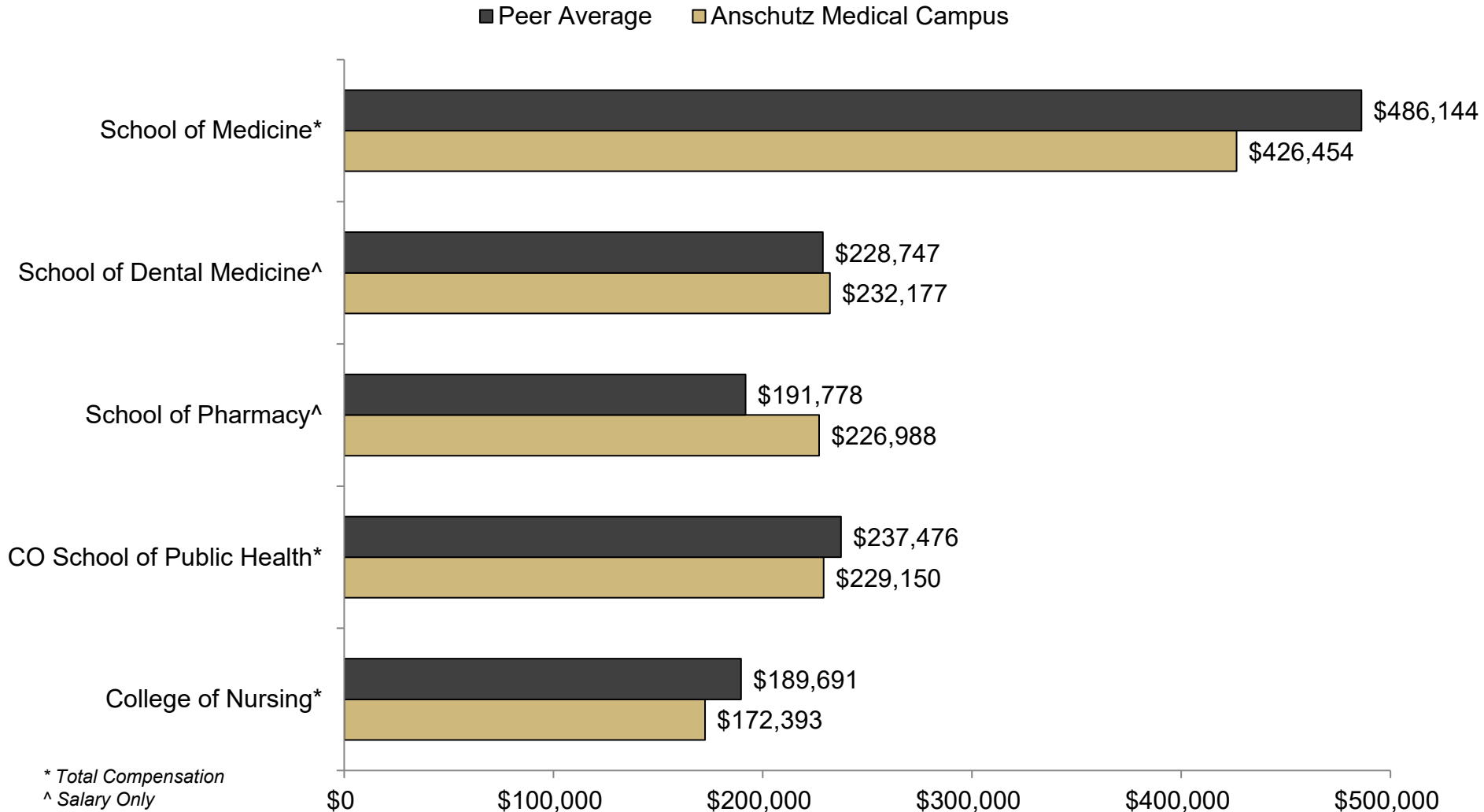

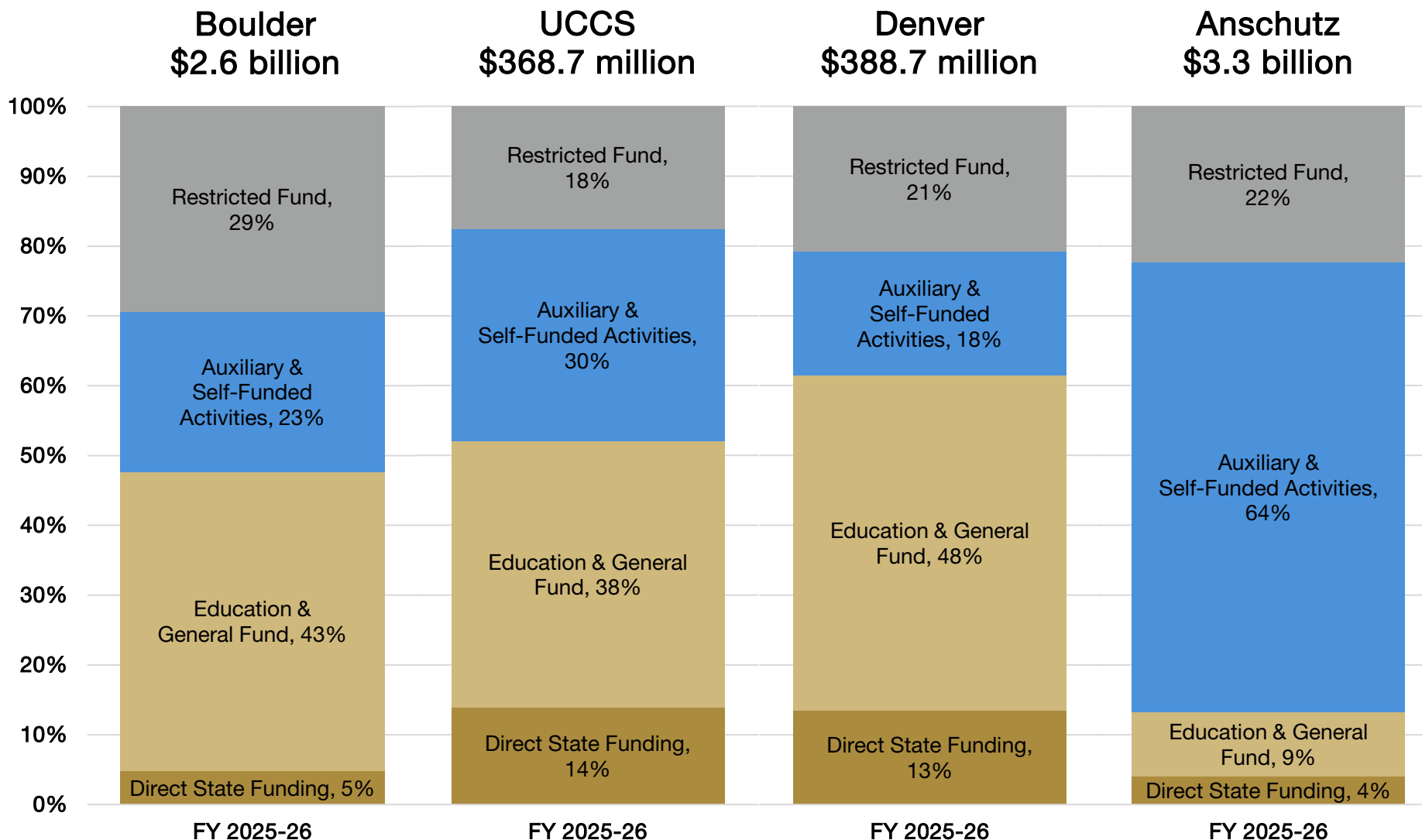

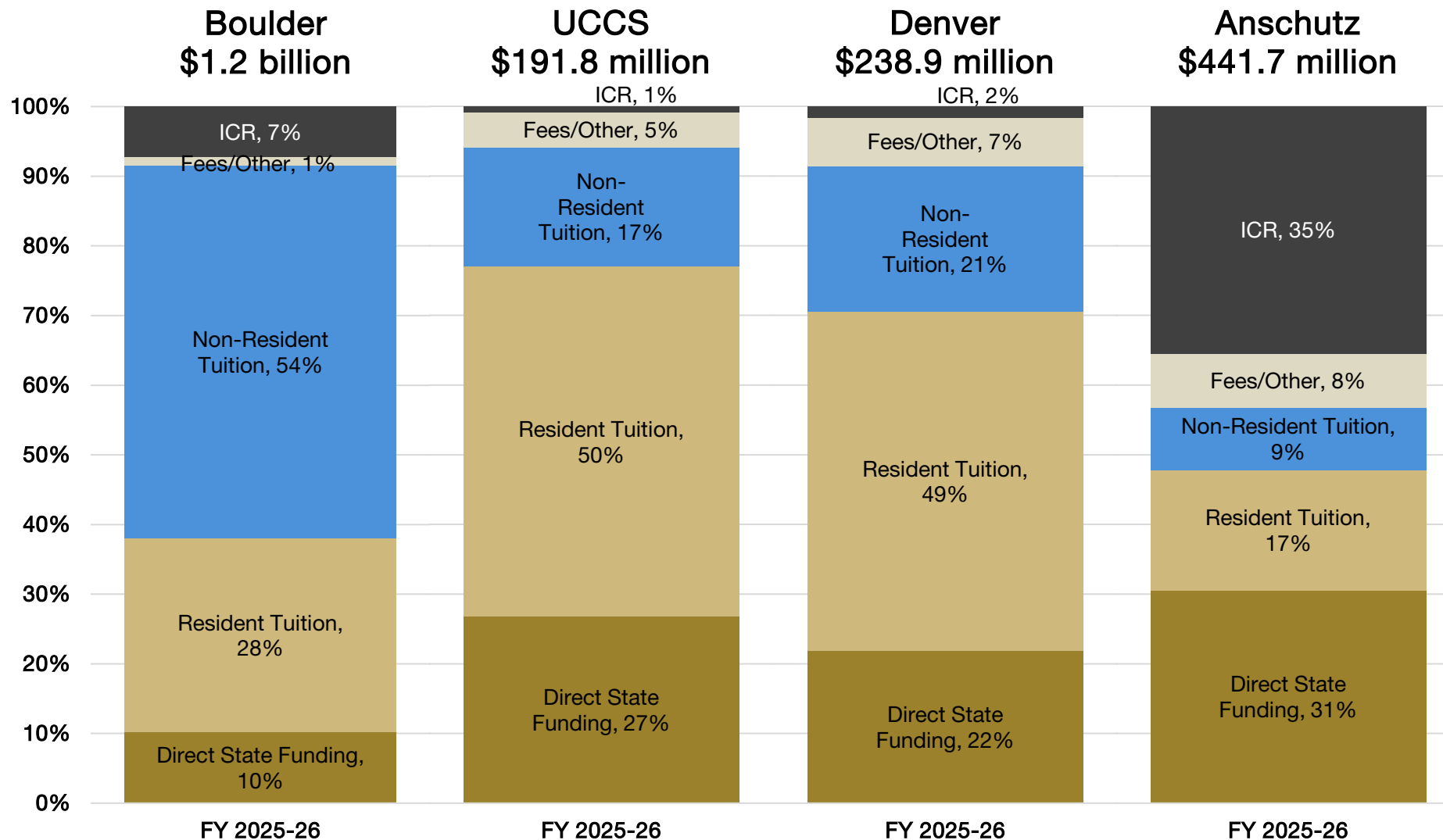

How are Dollars Spent?

Illustration below represents the share of Operating (Education & General) budgeted expenditures. In FY 2025-26, CU System approved operating budget was \$2.1 billion. Tuition and fee revenue makes up 66% of the operating budget, followed by 17% state funding, and 17% other E&G.

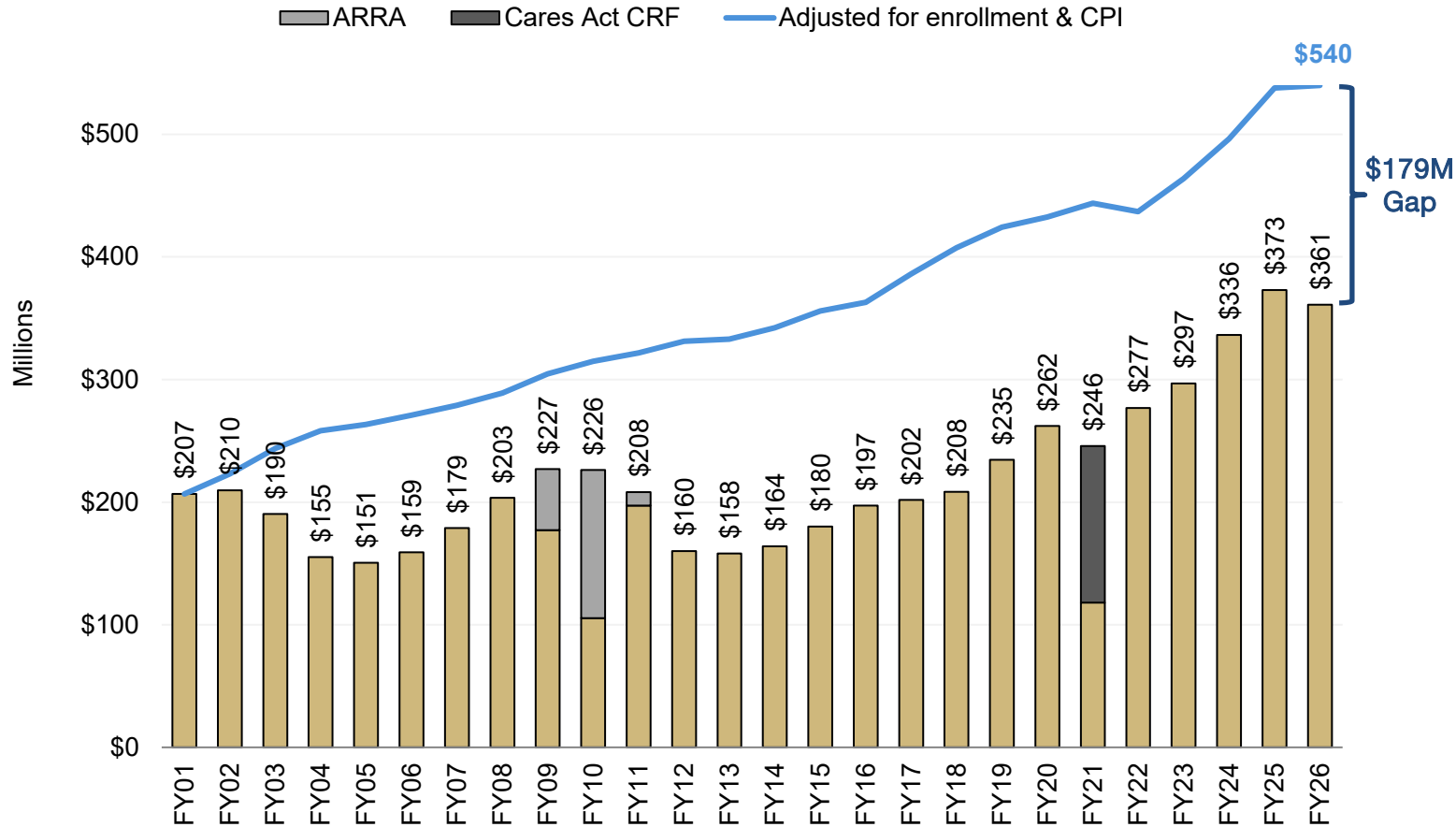

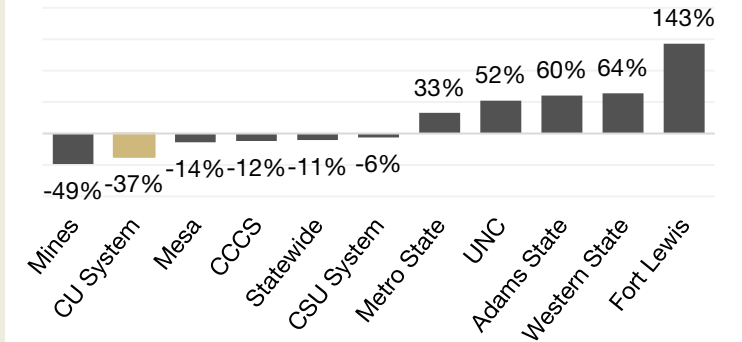
History of State Funding

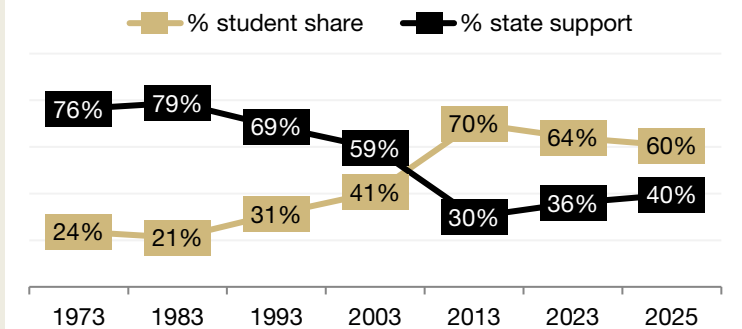


Since FY 2000-01, state funding per student FTE to CU has declined 37%

Change in State Support per Resident SFTE



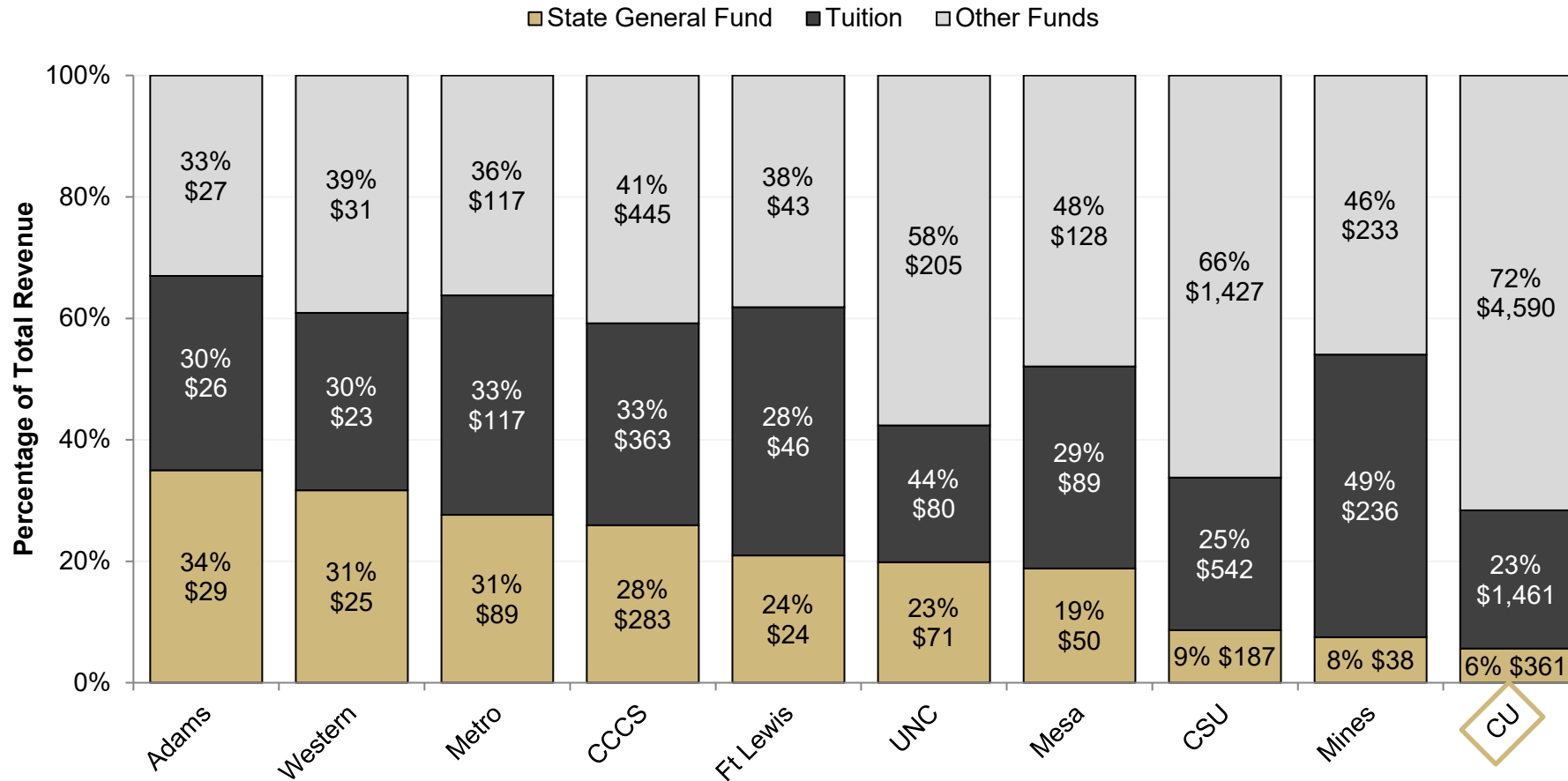

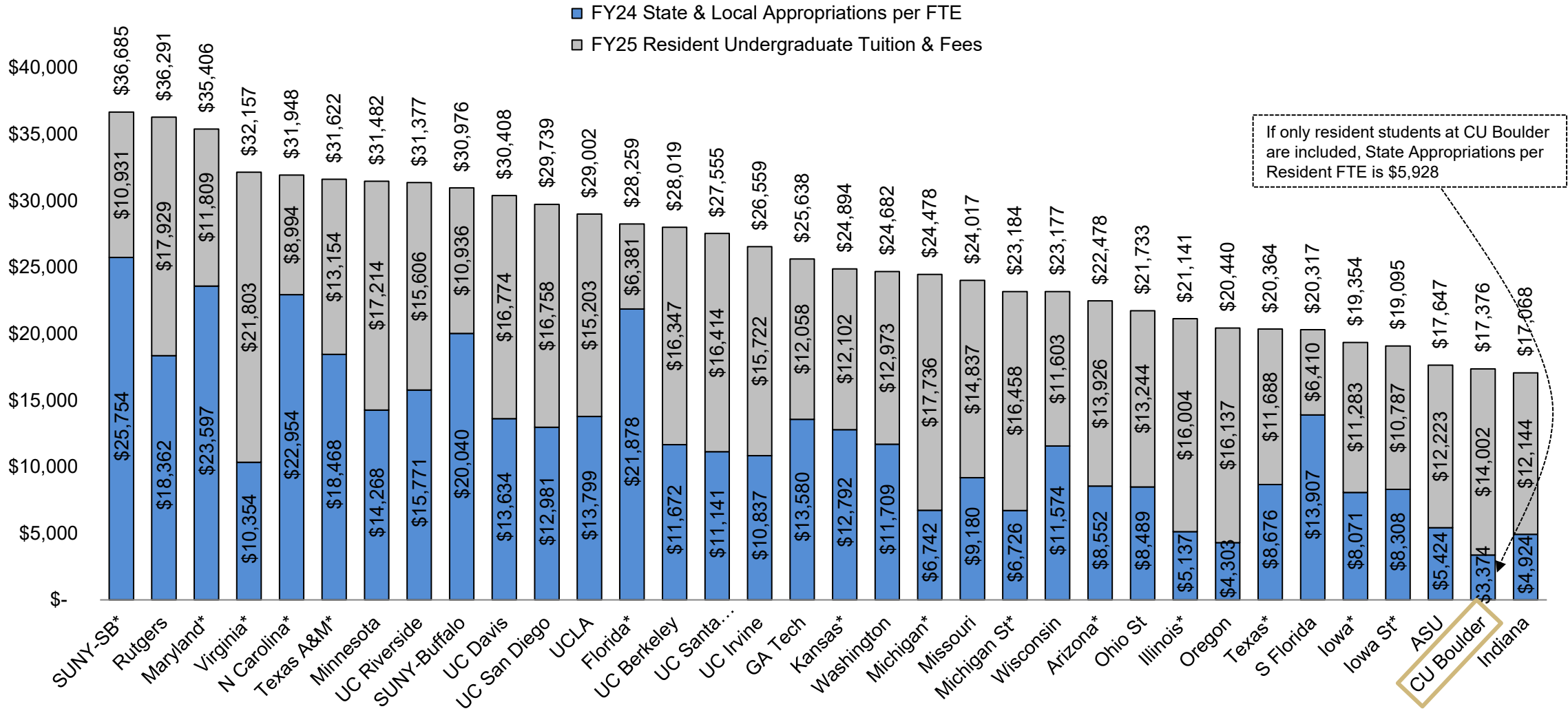

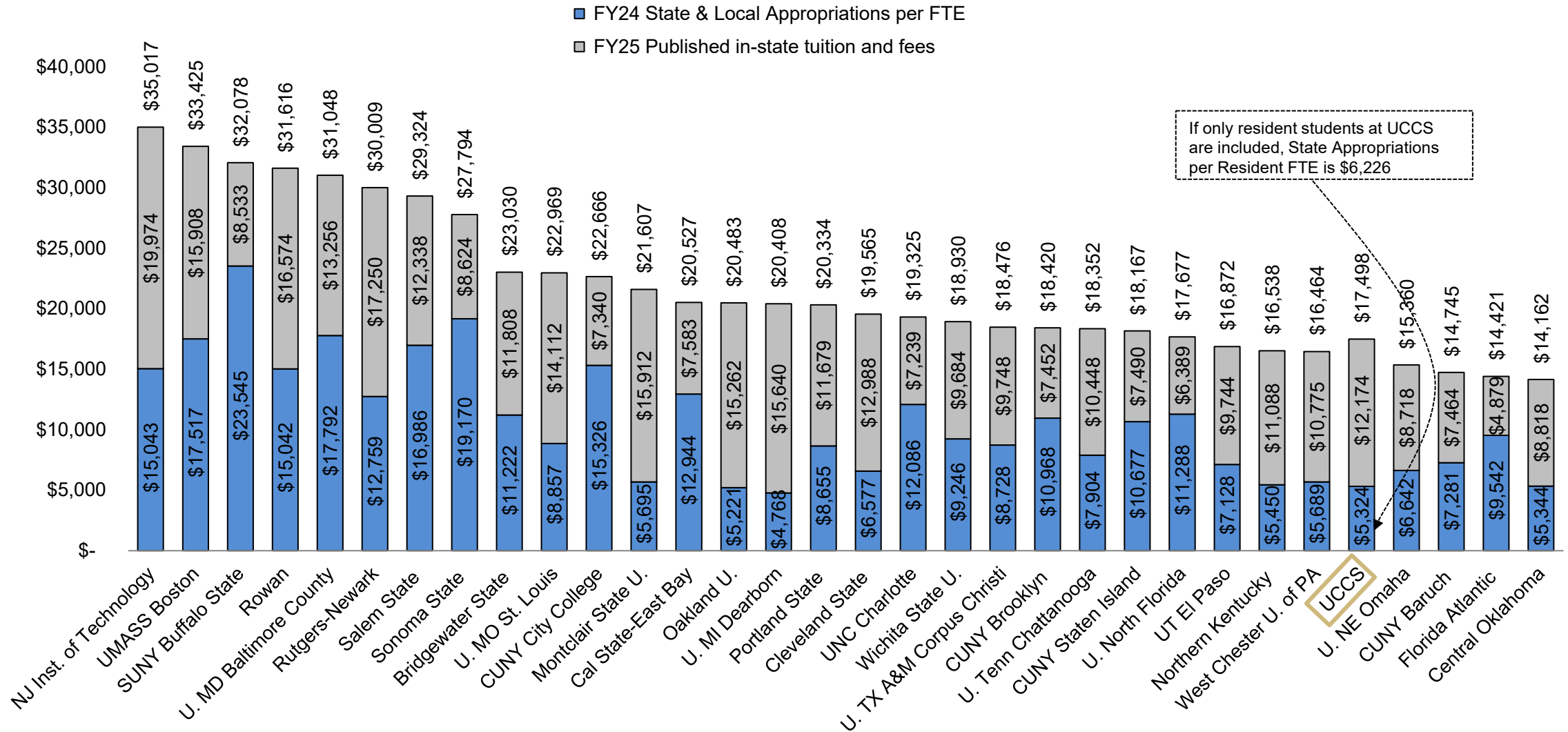
Undergraduate and Graduate Share of the Cost of Education, based on cost per student FTE



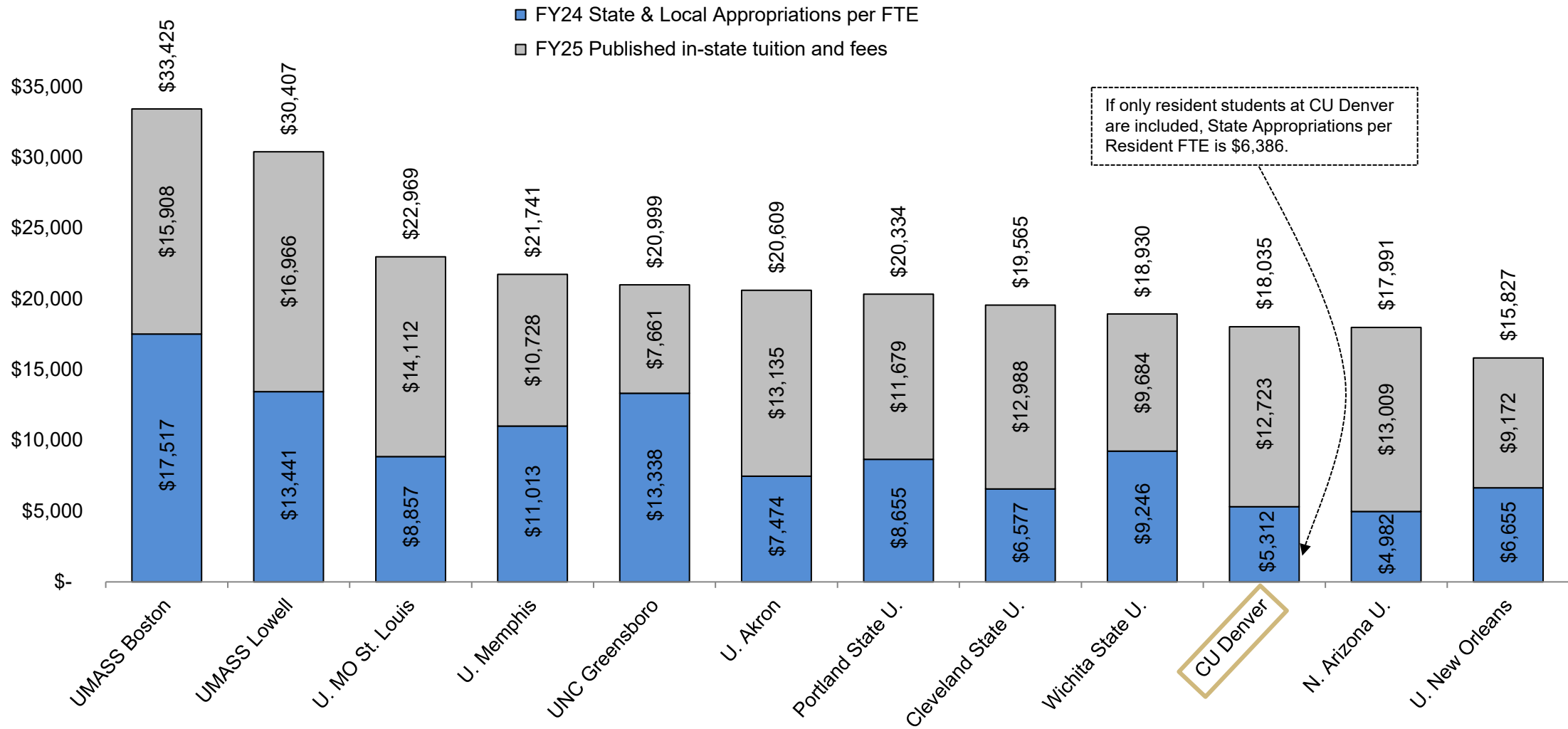

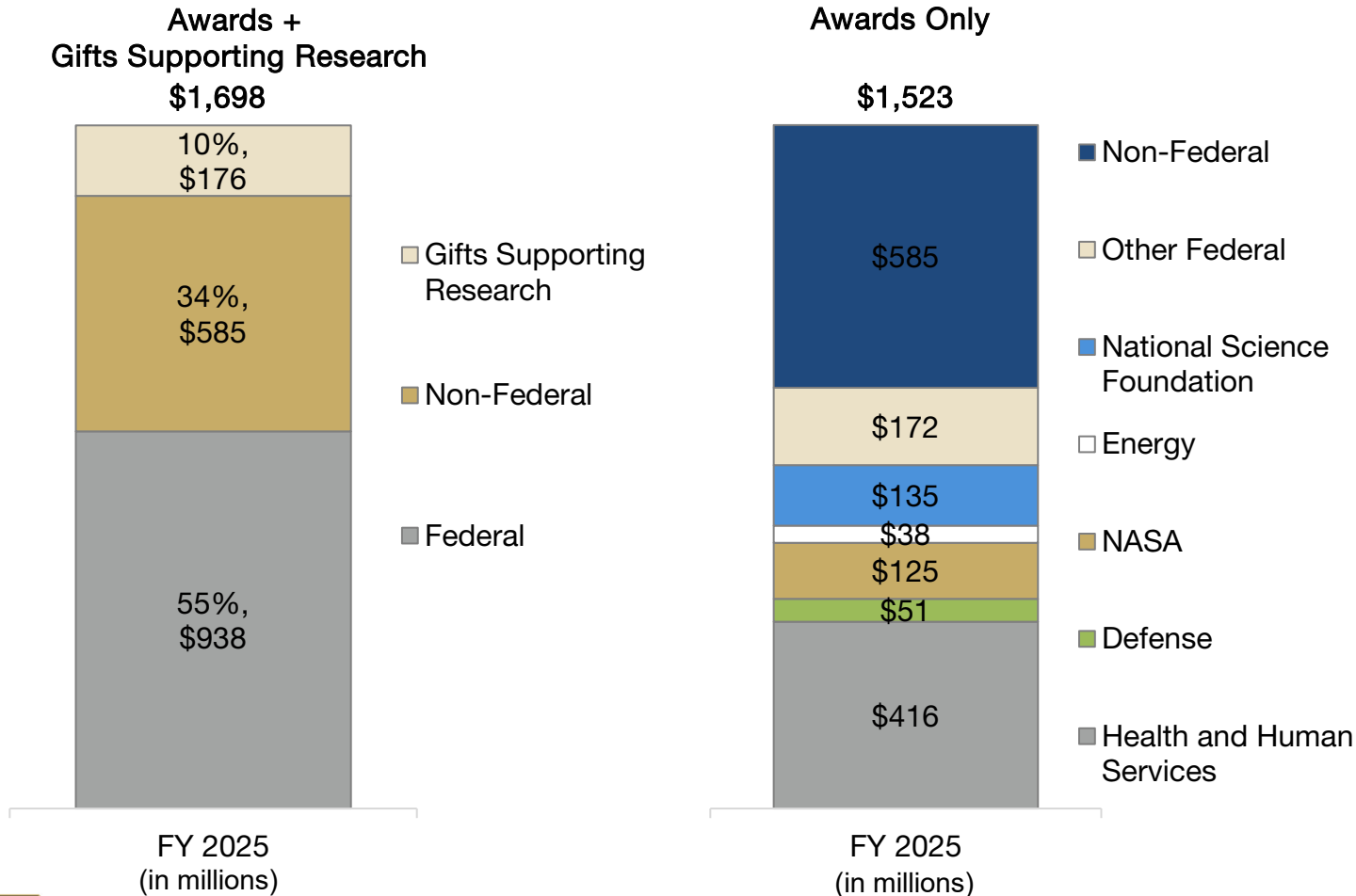

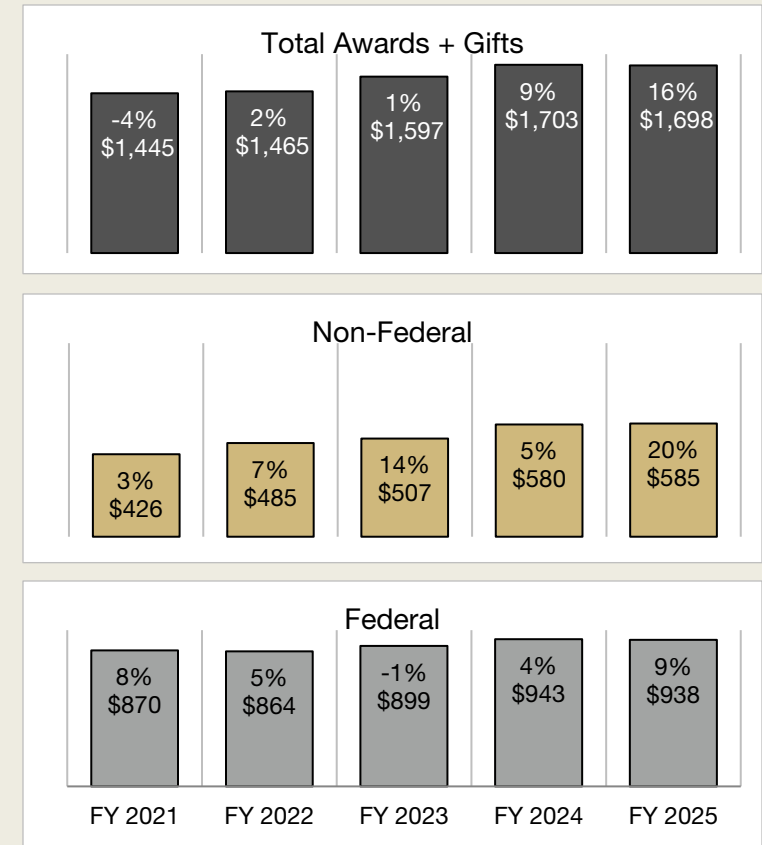

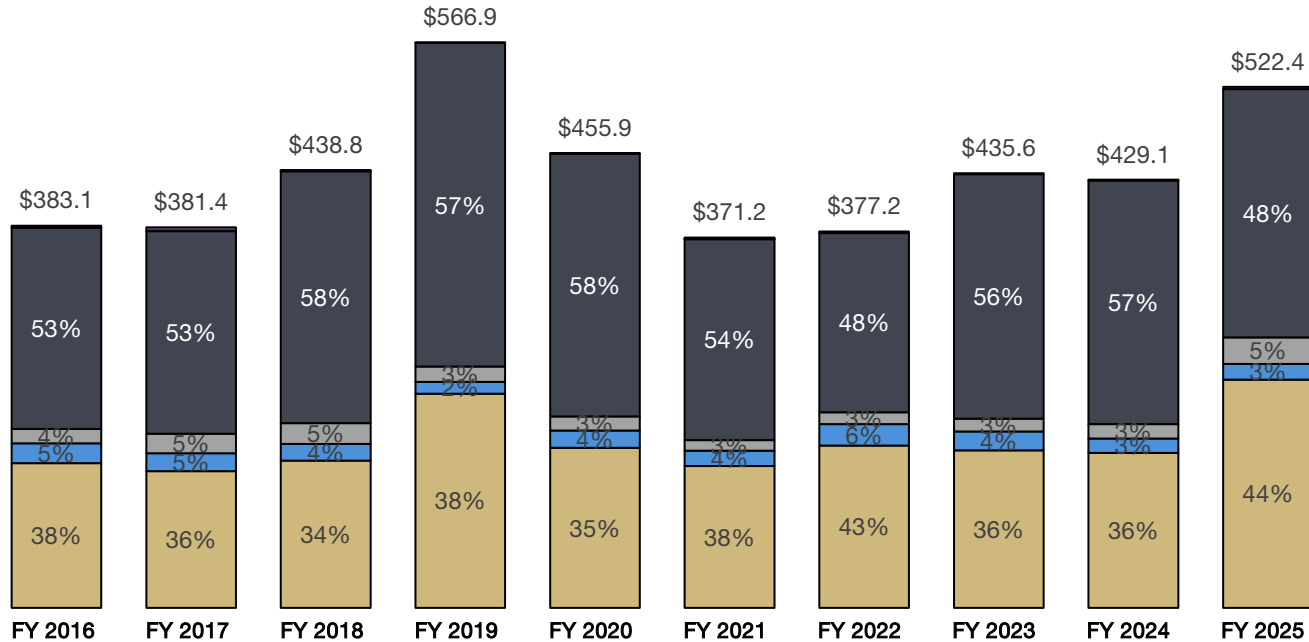

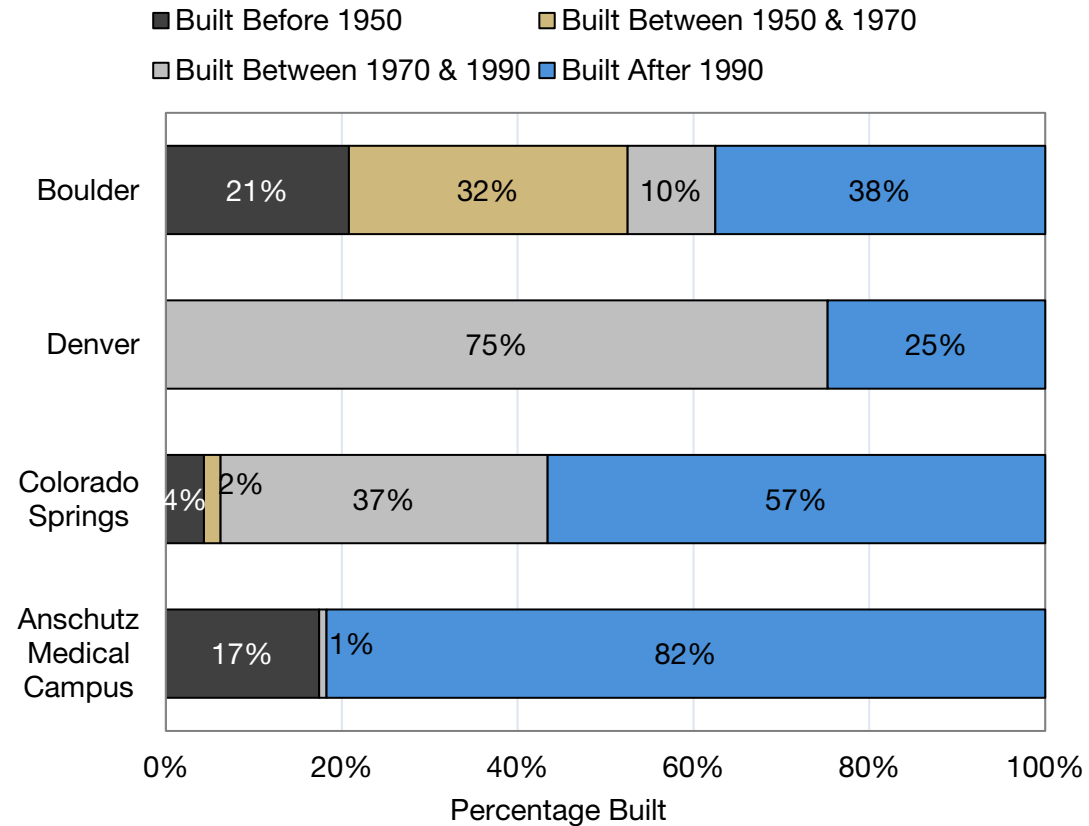
About the CU Foundation

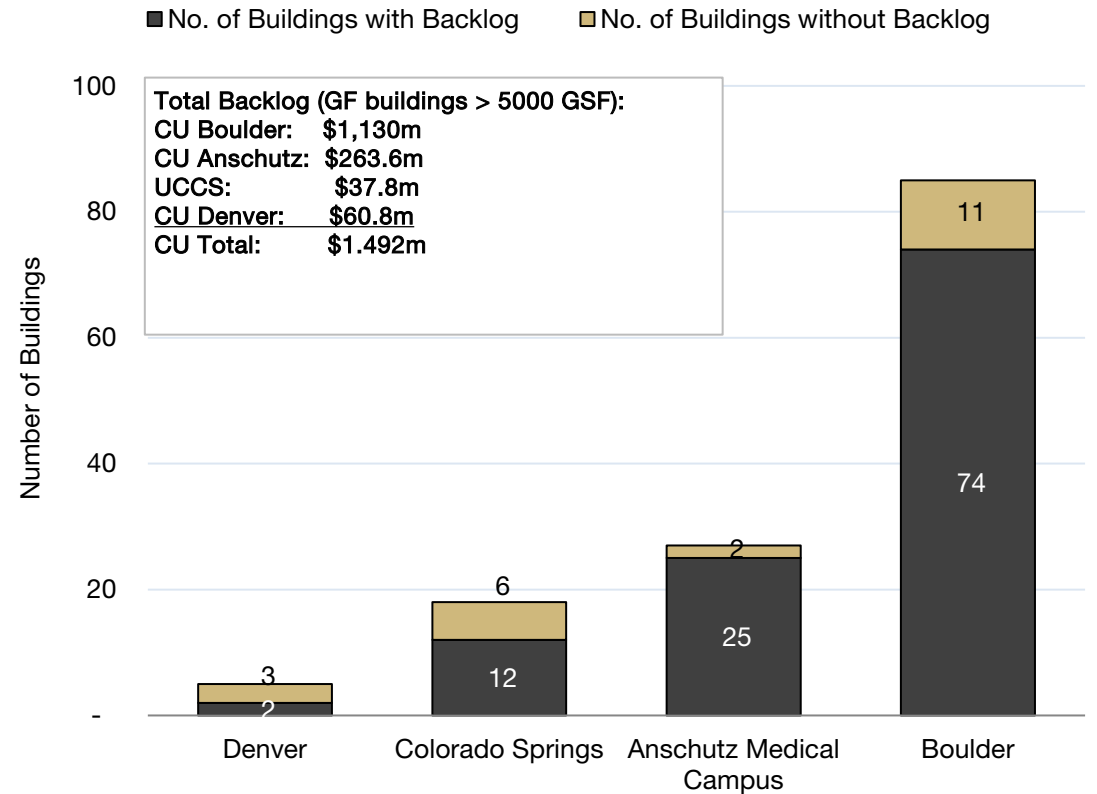

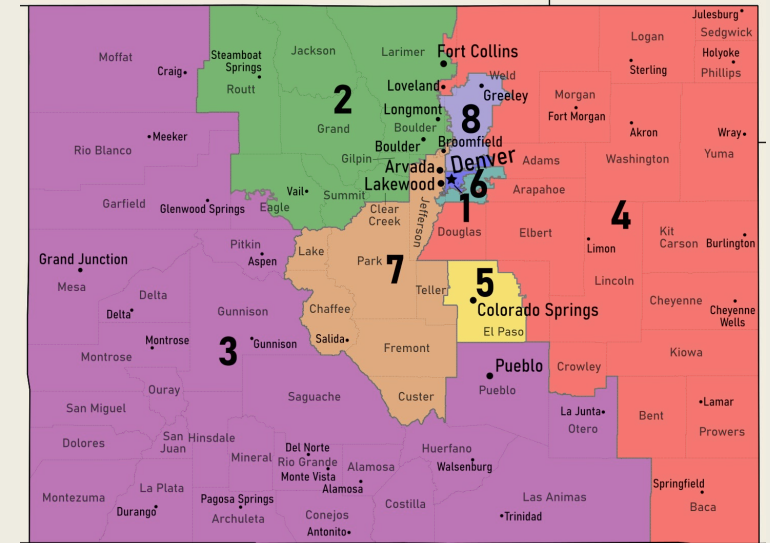

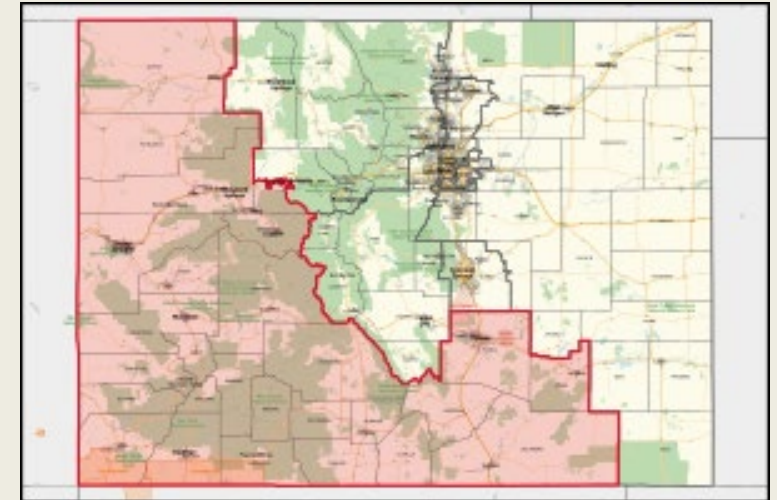

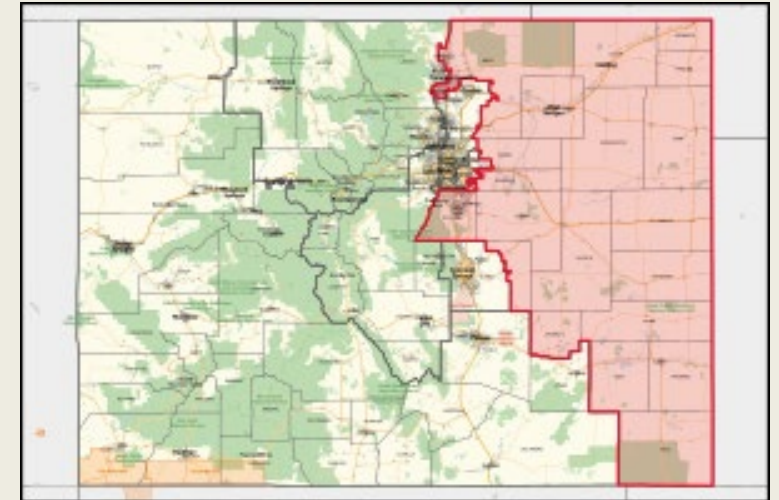

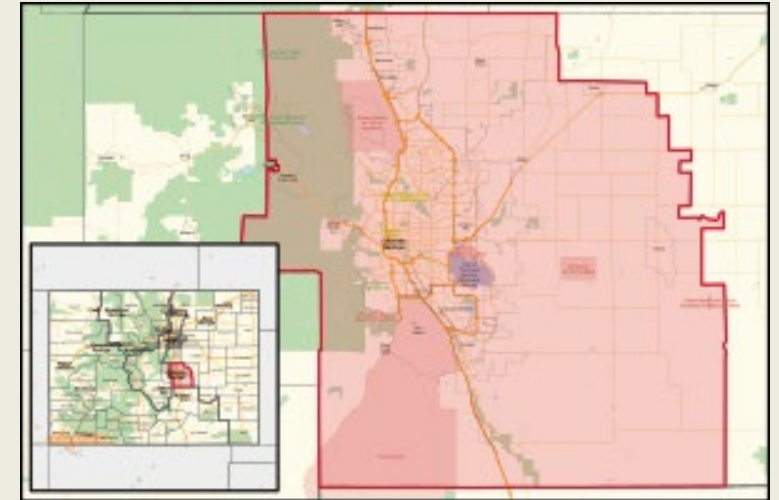

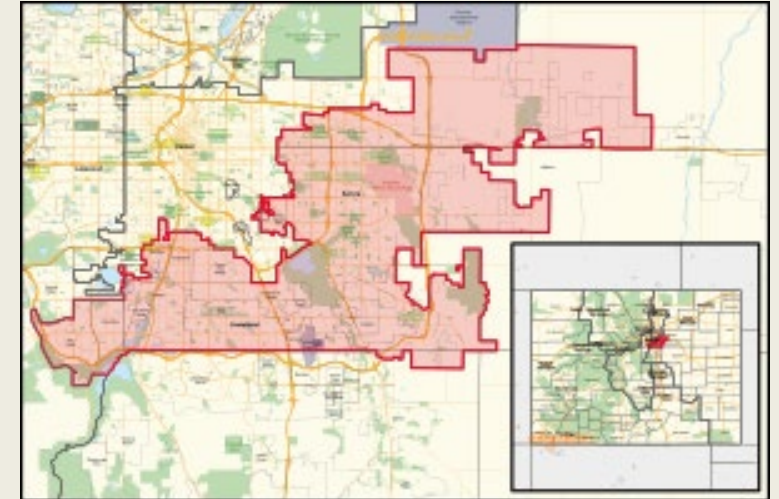

Colorado's Congressional District 6



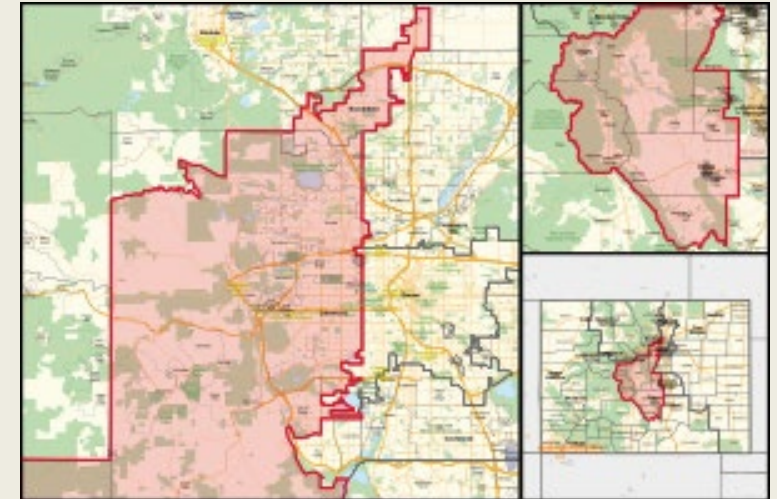
