### 1 LAWS OF THE REGENTS

### 2 3 **ARTICLE 3: OFFICERS OF THE UNIVERSITY AND ADMINISTRATION**

#### 4 5 **Part A: Officers**

6  
7 Officers are responsible for carrying out the strategic plans and policies as established or  
8 approved by the Board of Regents. Officers have executive powers delegated to them in the  
9 areas of academic programs and core administrative areas. Officers are subject to all federal,  
10 state and university laws and policies for University Staff<sup>1</sup>.

#### 11 12 **Part B: Officers of the University**

13  
14 There shall be five officers of the university: 1) the president; 2) the university counsel; 3) the  
15 secretary of the Board of Regents; 4) the treasurer; and 5) the associate vice president of  
16 internal audit.

17  
18 The Board of Regents shall elect the president in accordance with the laws of the state of  
19 Colorado.

20  
21 The Board of Regents shall elect the secretary of the Board of Regents in accordance with the  
22 laws of the state of Colorado.

23  
24 The Board of Regents, in consultation with the president, shall elect the university counsel, the  
25 treasurer, and the associate vice president of internal audit in accordance with the laws of the  
26 state of Colorado.

27  
28 The Board of Regents may appoint a single person to serve in the offices of university counsel  
29 and secretary of the Board of Regents in its discretion.

30  
31 All officers of the university serve at the pleasure of the Board of Regents.
