DRB Comments

General

A. Energy and Sustainability

No comments.

B. Site & Landscape Architecture

- The Board prefers the option with a longer ramp and no handrail.
 - Consider adding a small (4") curb on the bottom, low side of the ramp for wheelchair safety.
- Continue development of the planting plan.
 - Focus plantings on the upper level.
 - The plantings shown immediately next to the parking lot (at the curbline) won't thrive and should be removed or relocated.
 - Consider a few, larger groupings of plants, including multiples of one species especially the grasses and smaller shrubs, vs. more individual, disparate plantings shown in plan.
 - Evaluate planting choices. Laurel Raines, DRB member and landscape architect, suggests: Apache Plume; Peking Cotoneaster; spreading junipers: Armstrong Juniper or Tammy Juniper; upright junipers: Spartan Juniper, Cotinus Coggygria (Smoke Tree), Physocarpus (Ninebark species); grasses: Little Bluestem, Red Switch Grass.
- Explore the idea of creating a sense of place and identify for the school through the addition
 of color on the exterior wall to mark the location of the school. This could be a painted super
 graphic and soften the entrance and make it more friendly.

C. Architecture

Submittal for Design Development for a new playground at the Children's Hospital of Colorado site on the CU Anschutz Medical Campus.

DRB Comments

Due to a scheduling conflict, Tom Hootman was not present for this item. He reviewed the submittal prior to the meeting and had no comments.

General

• The DRB is very supportive of adding a new playground at Children's Hospital.

A. Energy and Sustainability

No comments.

B. Site & Landscape Architecture

- The DRB and the design team discussed the intended use of the playground. The DRB
 expressed concern that the current design doesn't reflect the needs of the terminally ill
 children who are supposed to benefit from the playground. Specifically, the current design
 seems very stimulating, and the site is not intimate. Additional feedback includes:
 - Explore a more soothing color palette for the playground equipment. Perhaps only hits of color should be incorporated.

- The location of the playground will be exposed to hot summer western sun. Conduct a sun/shade study to provide an understanding of the best times of day and months the playground will be best utilized. Consider the location of the awnings they are unlikely to project shade onto the fixtures below unless they are relocated.
- Study how the fence can be integrated into the overall design.
- Provide a site grading plan. Call out any retaining walls and detail how the landscaping accommodates the change in grade over the site.
- Continue to explore how to integrate landscaping at the site. Trees could be added to the south side of the site. Landscaping is one way that the site can be made more intimate and less exposed.
 - How can the site edges be softened? How can the playground be better integrated into the site? Could some of the ramps be in the landscape instead of added equipment?
 - One example discussed during the meeting is the new playground at the Denver Museum of Nature and Science.

C. Architecture

No comments.

DRB Action

The DRB did not take action on this item. The design team will revisit the design and resubmit at a later date.
