





# Legal Origin

“There shall be nine regents of the university of Colorado who shall be elected in the manner prescribed by law for terms of six years each.”

- Art. IX, Section 12, Colo. Const.

# Unusual Legal Entity


Only elected governing board of an institution of higher education in Colorado.

Only 4 governing boards are directly elected (Colorado, Michigan, Nebraska, Nevada).

Unique in our constitutional structure in that it exists independently of both the legislative and executive branches.

# Legal Status as Body Corporate

- Board “shall constitute a body corporate.”
  - Art. IX, Section 12, Colo. Const.
- Body corporate = Board can only act as a board
- Unless the Board specifically determines otherwise, no individual regent can act or speak for the Board.
  - Laws of the Regents, Art. 2.A.5(C)

Exercise General Supervisory Powers



Enact Laws and Policies for the University



Appoint and Evaluate the President



Appoint and Evaluate the Secretary of the Board, the University Counsel, the University Treasurer, and the Associate Vice President for Internal Audit


# Powers Delegated

- Supervisory responsibilities.






# Shared Governance

“The [Board] is the governing board charged with the governance of the university. It is a guiding principle of the shared governance recognized by the Board of Regents that the faculty and the administration shall collaborate in major decisions affecting the academic welfare of the university.”

- **Regent Law, Art. 5.A.1**

# Keeping Up with the Board

**BOARD OF REGENTS**

The Board of Regents is an elected board charged constitutionally with the general supervision of the university and the exclusive control and direction of all funds of and appropriations to the university, unless otherwise provided by law. The Board consists of nine Regents serving staggered six-year terms, one elected from each of Colorado's eight congressional districts and one from the state at-large. The Regents select their own chair and vice chair.

The Board holds five regular board meetings each year. The Board acts only at public meetings called in accordance with the state open meetings requirements and board laws and policies.




