PRO FORMA DEBT SERVICE COVERAGE¹

The Gross Revenues for the Fiscal Year ended June 30, 2025, as such term is defined in the Resolution, were \$2,263,229,000. FY 2025 Operating and Maintenance Expenses (as defined in the Resolution) were \$555,700,000, therefore, the Net Revenues for Fiscal Year 2025 as calculated in accordance with the Resolution, were \$1,707,529,000.

Fiscal Year 2025 Net Revenues, so calculated, divided by the Maximum Annual Debt Service as of 6/30/25 of \$163,692,000 payable on Outstanding Parity Bonds of \$1,633,465,000 was 10x.

¹ Historical Data. No representation is made as to future pro-forma debt service coverage. During FY25, The University entered into a \$50 million line of credit with a \$50 million uncommitted accordion as a parity obligation with US Bank. As of March of 2026, the University had not drawn on this bank facility.

On October 14, 2025, the University issued Series 2025C-1 Enterprise Revenue Bonds in the amount of \$76,540,000 to fund a portion of the Chemistry and Applied Math Building (CHAP) building and Ekeley remodel project at CU Boulder. Additionally, the University issued the Series 2025C-2 Enterprise Refunding Revenue Bonds in the amount of \$63,930,000 to refund Series 2021C-3A and selected maturities of the 2015A, 2015B, and 2015C series. The refunding transaction yielded cash flow savings of \$15,130,000 and present value savings of \$3,860,000. Savings from these transactions will lower debt service payments for all campuses. Interest rates range from 5.00 percent to 5.25 percent, and the first interest payment date is December 1, 2025. The final maturity of the 2025C-1 bonds is June 1, 2055 and June 1, 2051 for the 2025C-2 bonds.
