Description:

Pre-Design submittal for a small 80 SF prefabricated guard shack located at the entry to a loading dock along 17<sup>th</sup> Ave.

## **DRB Comments**

## A. Site & Landscape Architecture

- Study site to determine the best location for the shack;
  - Consider whether shack should be located on the right/driver's side upon entry to better and more safely coordinate incoming deliveries;
  - Verify access circulation;
- Identify necessary site improvements and provide details related to materiality;
  - Detail existing utilities and planned routing to shack;
  - Provide information about exterior lighting;
  - o Determine if bollards are necessary if so, match closely to existing context;
  - o Determine what signage, if any, will be required and where it will be placed; and
  - o Determine the location of the communication box.

#### **B.** Architecture

- Illustrate how the building relates to the surrounding context;
- Review the purpose of the shack and user needs before finalizing design;
- Determine whether existing shack will be treated as campus standard and, if so, what elements should be incorporated into design;
- Discuss design options with vendor:
  - o Can the pitch of the roof be changed?
    - A flat roof is preferred.
  - o Can the stucco finish be replaced with metal?
    - A metal panel finish above the brick is preferred.
  - o Can the windows be made uniform in size?
    - When studying the windows, consider the need for interior wall space.
