RE: Formal Review of Regent Policy 4.B: Academic Planning and Accountability

Feedback due by April 24, 2025

Policy 4.B: Academic Planning and Accountability

In May 2024, the Regent Governance Committee approved a five-year schedule for the continuing formal review of all regent laws and policies. As part of this process, **Regent Policy 4.B: Academic Planning and Accountability** is currently under review.

The initial draft of Policy 4.B posted as "Draft 0" on the Regent Law and Policy Review website included proposed updates to reference several associated APSs and also to remove language due to a change in statute. Details are summarized below. This draft was posted for stakeholder feedback last Fall. All comments received through a deadline of February 14, 2025, were reviewed and considered. Additional proposed updates are incorporated in "Draft 1" now posted for further feedback through April 24, 2025. Draft 1 is on the agenda for first discussion at the Regents Governance Committee on March 25, 2025.

Policy 4.B was last reviewed and affirmed by the regents in January 2018. Proposed updates include the following:

- Proposed updates include the addition of references to specific APSs that are connected to sections 4.B.3, 4.B.4, and 4.B.6 of this policy.
- An edit is proposed in Section 4.B.4 about language regarding the role of faculty, administration, and the provost in participating in the recommendation process for program discontinuance. The suggestion is to remove lines 40 43 in favor of simpler wording that points to the detail contained in corresponding APS 1015. (Updated in Draft 1, April 21, 2025)
- In Section 4.B.4 on program discontinuance, the reference to termination of appointments "of tenured and tenure track faculty" is updated to refer more generally to "faculty appointments." Policy 5.F which addresses termination of faculty appointments following program discontinuance refers to both tenured/tenure-track faculty and IRC faculty. Changing the reference to faculty appointments in 4.B.4 ensures consistency with Policy 5.F. (Updated in Draft 1, April 21, 2025)
- In compliance with *HB22-1049 Prohibiting Transcript and Diploma Withholding*, the clause in section 4.B.5 of this policy that allowed withholding of academic transcripts for failure to meet financial obligations to the university has been removed.
