Marketplace Reminder Viewing Invoice Images

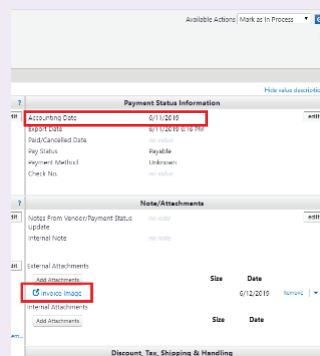
Have you had trouble opening up invoice images? Now is the time to try again – since we recently upgraded to a new platform for ImageNow. (That's the software by Perceptive Content that lets you look at images of invoices attached to vouchers in the Marketplace.)

With this new platform, you can open up invoice images without having to worry about Java ... or which internet browser you're using. Just click on the **Invoice Image** link in the bottom right of the voucher screen.

Note:

Invoices that were uploaded in the previous version of the software still require Java and Internet Explorer.

If you can't open an image, take a look at the **Accounting Date** – you'll find this field in the top right of the voucher screen. The accounting date is the date that the voucher was entered, which means that it's the date that the invoice was uploaded. If this date is before June 24, 2019, the invoice was uploaded through the previous ImageNow software platform ... so Java/browser restrictions still apply.
