Project Status & Timeline

- The project is behind schedule due to delays with the HIPAA compliance set up and the unsuccessful search for the Tableau analyst.
- The UIS team still hopes that migrations will be conducted in late spring or early summer and we will coordinate with your business calendar and other projects. Your migration timeframe will not be a surprise.
- Status reports will be sent to stakeholders bi-weekly.

Project Status & Timeline: Q&A

- Question: Can UIS proceed with Tableau set up and achieve HIPAA compliance later?
 - Answer (Milap): No, per the Office of Information Security, we must achieve HIPAA compliance in AWS, which is a new tool and doesn't have a precedent for compliance. The UIS team can complete *some* set-up work, but cannot put data in Tableau until HIPAA (and NIST) compliance is achieved.
- Question: What is the timeframe for NIST/HIPAA compliance to get back on track?
 - Best-case scenario is 6-8 weeks. Likely a bit longer before that work is on track with full confidence on the timeline.
- Question: Denver Med School contract expires in December is that a concern?
 - No, we have a full 6 month cushion between our original migration timeframe and
 December UIS team is not concerned.
