HR Update

Tony reported that the independent review of the Health Trust for the last fiscal year has been completed and no audit findings were found. The audit report is now posted on the Trust's website (https://www.cusys.edu/trust/documents/2014-cuhp-audit.pdf). The audit report is posted on the Trust website. Tony went on to discuss Trusts' True-Up policy and his recent request for a reserve that is managed through policy and has a fully funded budget.

Anthem Security Breach

Tony reported that he has requested an extended credit monitoring service for CU employees, in addition to the two years' service offered by Anthem as a result of the data breach.

Open Enrollment

Tony discussed the following design changes to the health plans offered to employees:

- A health savings account (HSA) will be added to the high deductible health plan. The
 HSA will be offered through Wells Fargo bank and sponsored by the health plan. It will
 be free to employees.
- A diabetes prevention program, acupuncture services and transgender surgery will be added to the health plan.
- All plans will see a 6% premium increase, except the high deductible plans. There will
 be no increase in the Medicare plan and only a minor increase in the Kaiser and
 exclusive plans.

Responding to this update, committee members noted that they would like to see better dental, vision and hearing benefits for retired faculty.

Lisa Landis went on to report that the Access Plan will be discontinued and replaced by the Anthem Extended Plan, which will provide nationwide coverage for enrollees. Open enrollment will start on April 27 and end of May 11, 2015.

Retirement Benefit Town Hall Meetings

Lisa reported that retirement workshops have been held on each campus and were attended by over 1,000 people.
