Led by PI Danna Gurari, PhD, and joined by co-PI Jeffrey Hebert, PhD, and lead researcher Jarek Reynolds, PhD student, their project is titled "Vision Canceling Technologies for Individuals with Traumatic Brain Injuries." We have also been busy attending industry events. As mentioned in the last newsletter, I attended the annual Consumer Electronics Show (CES) in Las Vegas in January.
