- **Failed Sends:** As mentioned in last week's digest, CU Boulder Advancement has been reporting an increase in failed sends. We've elected to open a case with SFMC to address this issue. We will provide an update as soon as possible.
- **Preferred Name:** The UIS integrations team has set up the preferred name integrations in stage. Daniella Torres is currently working on a test plan and will provide another update soon.
- **Multi-Factor Authentication:** CU Anschutz and Denver are concluding MFA for all users this month. Any outliers from the other campuses have also been included in recent notifications. If anyone has still yet to enroll next week, the MEC will be notified to require the user to take action or submit a deprovision request.
