This year, the university's [Family and Medical Leave Insurance \(FAMLI\)](#) <sup>[3]</sup> introduced a significant new benefit for all CU employees. This benefit offers paid leave in addition to existing federal Family and Medical Leave Act (FMLA) job protections and CU's Parental Leave benefit.

The interplay of these leave programs, the process for applying and requirements to document these types of leave present a steep learning curve for everyone involved. Over the next six months, the Employee Services Leave Team will host a series of webinars for distinct audiences — HR liaisons, supervisors and employees — focused on learning more about these three leave programs.
