PERA webinars and resources

Classified staff and those with prior PERA-eligible state employment may be enrolled in one of the PERA-administered retirement plans — [Defined Contribution \(DC\)](#) ^[12] or [Defined Benefit \(DB\)](#) ^[13]. Additionally, all benefits-eligible employees can opt to enroll in one of PERA's two [voluntary retirement accounts](#) ^[14], the [401\(k\)](#) ^[15] and [457](#) ^[16] plans.

PERA offers an [extensive webinar library](#) ^[17] for all plan types, including many videos in Spanish. You can either view recorded webinars or register for live ones. Use PERA's [interactive tool](#) ^[18] to help you decide which webinars to prioritize if you're not sure where to start.

Additionally, the [PERA resources page](#) ^[19] includes calculators, plan-specific documents, necessary plan forms, frequently asked questions and more.

CollegelInvest webinars

Colorado offers tax-advantaged 529 college savings plans, managed by CollegelInvest, to

help individuals and families save for higher education costs. CollegenInvest hosts quarterly webinars, where attendees receive \$50 toward a new 529 account just for participating.

Additionally, the [First Step Program](#) [20] helps new parents jumpstart savings with a \$121 initial contribution to new accounts for any child born or adopted in Colorado on or after January 1, 2020. Parents or legal guardians who start an account for an eligible child **by Dec. 31, 2026** can take advantage of this unique one-time benefit. The First Step Program will match your contributions up to \$500 per year for three years — up to **\$1,500 total** — giving families an even stronger boost as they begin building education savings.
