

## **Tuition Assistance Benefit applications now open for Summer 2021** <sup>[1]</sup>

Consider summer school an opportunity for growth. The Tuition Assistance Benefit application window is now open for the summer 2021 semester in the [employee portal](#) <sup>[3]</sup>.

Qualified employees can save on up to nine credits per academic year (fall through summer) on any CU campus, and their children, spouses and other dependents have several options to save on tuition costs. [Dependent options](#) <sup>[4]</sup> vary based on whether classes are taken on the employee's campus of employment or not.

  - June 15 for Summer
- [CU Colorado Springs: June 21](#) <sup>[8]</sup>

2. Open the **CU Resources** dropdown menu, and select **Forms**
3. Click the **Career Advancement** tile, then click the **Tuition Assistance Application** tile

### **Fall 2021 semester policy changes**

Starting with the fall semester, employees can register seven (7) days prior to the first day of the semester or the first day of class, whichever is earlier.
