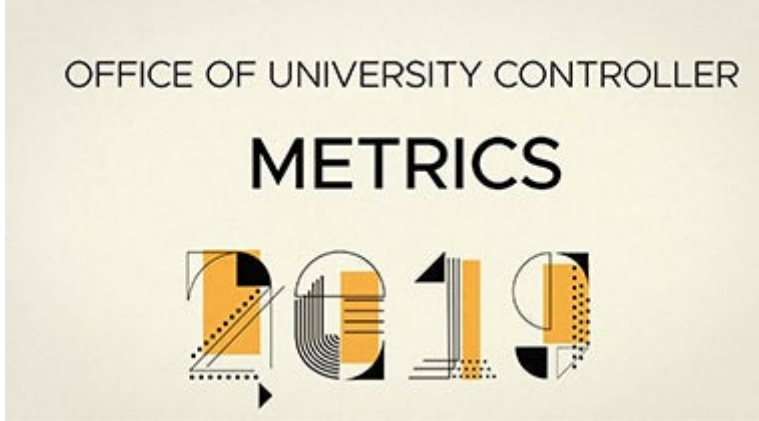

With 2016, the OUC continued to monitor to reduce expenses, promote efficiency, and foster innovation, as outlined in the [2016 Strategic Plan](#).

Here are some of the things our employees did to help emphasize values for additional and fully meet fiscal goals and responsibilities:

- Elevate Project Finance Upgrade**  
We completed the new Finance System (FIS 9.2) in December 2016, but continued to work on the new FIS and Upgrade module functionality and processing.
- Fiscal Certification**  
Throughout a fiscal Fiscal Certification, fiscal and staff of the top administration have 100% compliance with the Fiscal Certification perspective, the advanced addition of compliance for this process by following best practices. The questions asked of internal control environments and further (the entire web form whereby these questions are asked and answered) from feedback from participants.
- Copcon: a single solution to University financial reporting**  
Our year-end fiscal reports in Copcon have received a number of other outside reporting systems and will help (foster) transparency, best practices, and standardized financial reporting capability. Plus, we continued to address the longstanding need for fiscal report automation at CU by engaging staff employees through the [Automated Fiscal Day](#) and by providing training through a variety of best color materials and through OUC courses.

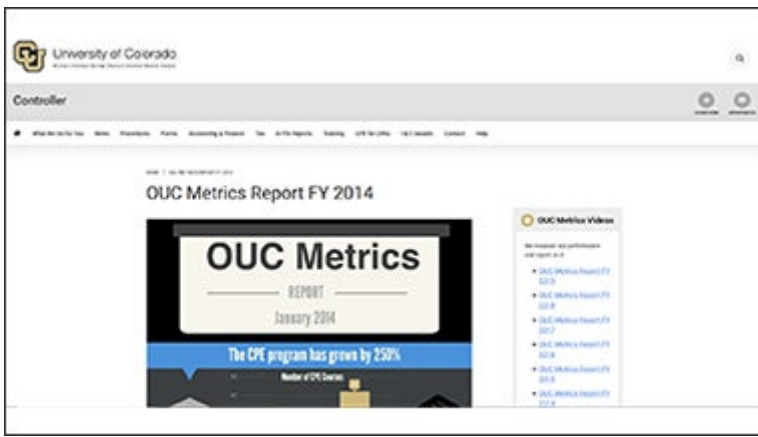
