The Pathway plan provides access to high-quality health care in Colorado through Anthem's Pathway network

NetworkThe facilities, providers and suppliers with whom your health insurer or plan has contracted to provide health care services [2].

Colorado in-network hospital systems include Rocky Mountain Children's Hospital, Boulder Community Hospital, HCA Hospitals and UC Health Hospitals. Children's Hospital Colorado will be out-of-network, except for emergencies.

Members living outside of Colorado will have access to Anthem's full national PPO network on the Pathway plan, the same out-of-state network as the High Deductible plan.
