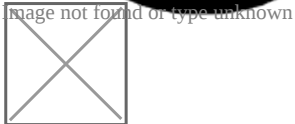

The director provides leadership and support for innovative and future-thinking academic initiatives and emerging tools such as adaptive learning platforms, competency-based credentialing including badging, artificial intelligence, and augmented/virtual reality. They also sustain and further develop successful existing innovations, such as the highly regarded annual COLTT conference, Open Educational Resources (OER) initiatives, MOOCs and associated operations with campus partners, the student success and digital badging initiatives, and provides oversight of regulatory support as requested by all four campuses for online state authorization processes and compliance activities. Henthorn has instructed courses at the College of Architecture and Planning at CU Denver and has prior experience in many facets of the University's international affairs. She received a BA from Northwestern University, an MFA from Edinburgh College of Art, and a Ph.D. in Artistic Practice as Research at the University College London.
