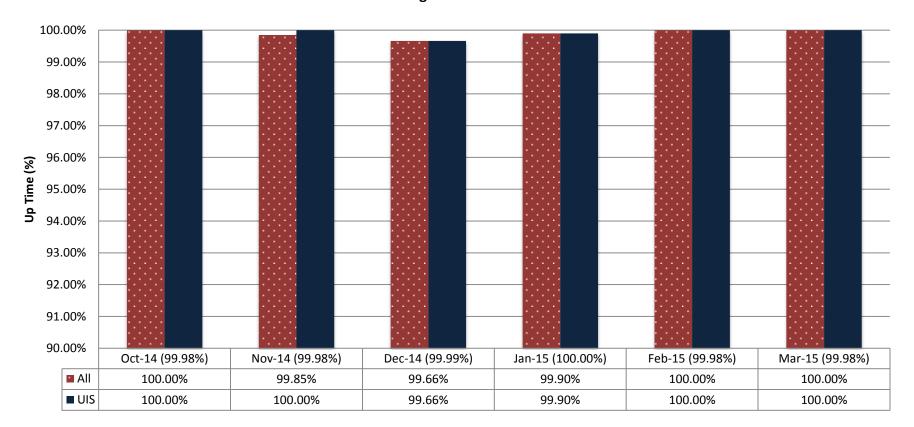

Assuming 24 hr by 7 days with Holidays **Excluding Planned Maintenance** 



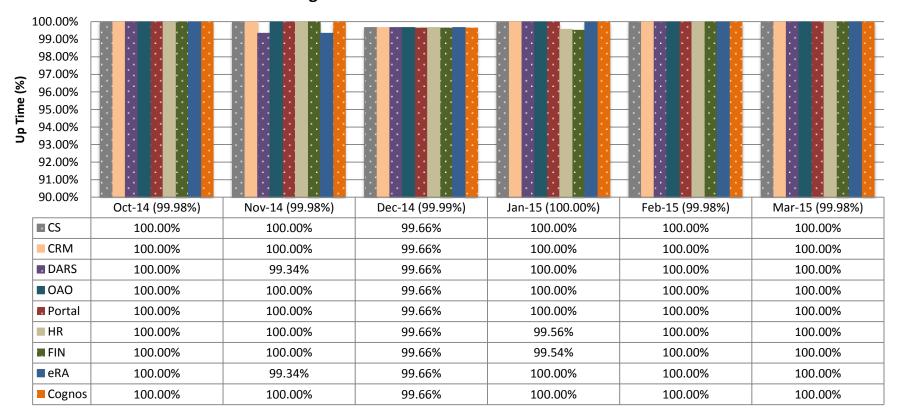

Assuming 24 hr by 7 days with Holidays **Excluding Planned Maintenance Windows** 

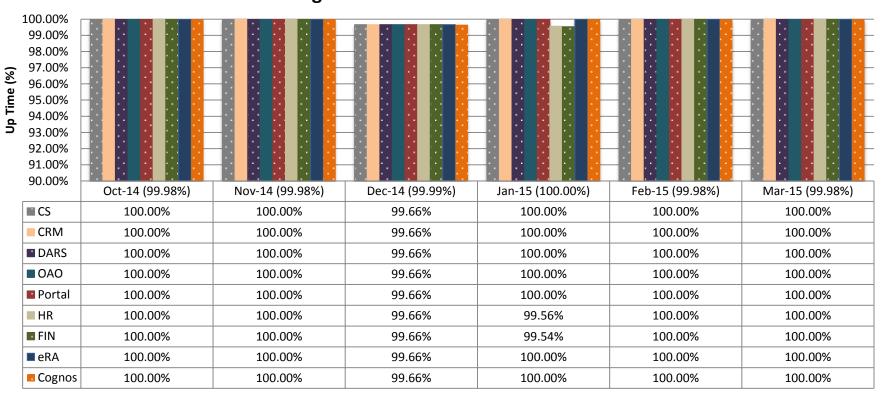
