The PSC is pleased to announce that CU has entered into a new relationship with Federal Express. (FedEx) The most significant benefit of the new agreement is lower shipping costs on domestic shipments. Other benefits include same-rate shipping by weight anywhere in the continental United States, waivers on certain fees, and caps on fuel surcharges.
